## POWER LINE EASEMENT STATE AGENCY

KNOW ALL MEAN BY THESE PRESENTS, That the undersigned on behalf of the State of Alabama, Department of Conservation and Natural Resources, a state agency, (the "Grantor") for an in consideration of the sun of One and No/100 Dollar (\$1.00), to it in hand paid by the Alabama Power Company, a corporation, (the "Company") the receipt whereof is hereby acknowledged, does, pursuant to its authority under Code of Alabama (1975), Section 16-3-26, hereby grant to said Alabama Power Company, its successors and assigns, the right from time to time to construct, install, operate and maintain, upon, over, under and across the Property described below along a route to be selected by the Company which is generally shown on the Company's final location drawing (which shows the general location of underground Facilities, if any, by hatching indicating an area not greater than ten feet (10') in width), all poles, towers, wires, conduits, fiber optics, cables, transclosures, transformers, anchors, guy wires and other Facilities useful or necessary in connection therewith (collectively, "Facilities"), for the overhead and/or underground transmission and distribution of electric power, and also the right to clear and keep clear a strip of land extending five feet (5') to either side of the center line of underground Facilities and fifteen feet (15') to either side of the center line of overhead Facilities; further, the right in the future to install and utilize intermediate poles in line for overhead Facilities and the right to trim and cut and keep trimmed and cut all dead, weak, leaning or dangerous trees or limbs outside of the thirty foot (30') strip for overhead Facilities that, in the sole opinion of the Company, might now or may hereafter endanger, interfere with or fall upon any of the overhead Facilities.

The easements rights and privileges granted hereby shall apply to, and the word "Property" as in this instrument shall mean the following described real property situated in Escambia County, Alabama ("the Property"):

A parcel of land located in the West ½ of the SW ¼ of Section 5, and the East ½

A parcel of land located in the West ½ of the SW ¼ of Section 5, and the East ½ of the SE ¼ of Section 6, all in Township 20 South, Range 2 West, and recorded in Deed Book 114, Page 579, in the Office of the Judge of Probate, Shelby County, Alabama.

The above-referenced final location survey is Alabama Power Company's Drawing number WE # A6170-06-AF10 which is attached hereto and made a part hereof as Exhibit "A".

Grantor hereby grants to the Company all easements, rights and privileges necessary or convenient for the full enjoyment and use thereof, including without limitation the right of ingress and egress to and from the facilities, and Guy Wires Facilities, as applicable, and the right to excavate for installation, replacement, repair and removal thereof; and also the right to cut, remove and otherwise keep clear any and all structures, obstructions

or obstacles of whatever character, on under and above said Facilities and Guy Wires as applicable.

In the event the grantee exercises its rights hereunder to install, replace, repair, or remove said facilities, grantee agrees to restore the surface of the premises of the grantor to substantially the condition which existed prior to the installation, replacement, repair, or removal of such facilities. Such restoration by grantee shall exclude, however, any shrubbery or landscaping installed by the grantor subsequent to the initial installation.

TO HAVE AND TO HOLD the same to the said Company, its successors as assigns forever.
