THIS AGREEMENT is made and entered into on this 25th day of March, 2011, by Regions Bank (Hereinaster referred to as "Regions") in favor of MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC. as nomInee for QUICKEN LOANS, INC, its successors and assigns (hereinafter referred to as "Lender").

RECITALS

Regions loaned to James L Griffin (the "Borrower", whether one or more) the sum of \$80,000.00. In consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of all of which is hereby acknowledged, Regions agrees that the Mortgage shall be and remain at all times a lien or charge on the property covered by the Mortgage prior and superior to the lien or charge of Regions Bank to the extent the Mortgage secures the debt evidenced by the Note and any and all renewals and extensions thereof, or of any part thereof, and all interest payable on all of said debt and on any and all such renewals and extensions, and to the extent of advances made under the Note of the Mortgage necessary to preserve the rights or interest of Lender there under, but not to the extent of any other future advances.

By its acceptance of this agreement, the borrower agrees to pay the subordination fee set out in the Regions Subordination Request Form.
