This matter comes before the Court upon Application of the Plaintiff and hearing to confirm an Award (the "Award") in the AAA Arbitration entitled, *In the Matter of the Arbitration Between Innowave USA LLC v. Aquapure Water Systems, LLC*. AAA Case No. 57 155 E 00142 10, which was entered into on September 29, 2010.

Upon consideration of the premises, the Application, and the Award, the Court finds as follows:

IT IS HEREBY ORDERED THAT:

1. Jurisdiction of this Court is invoked pursuant to Neb. Rev. Stat. § 25-2618.
2. Venue is appropriate in this Court pursuant to Neb. Rev. Stat. § 25-2619.
3. That Matthew M. Enenbach of Kutak Rock LLP has voluntarily appeared on behalf of Innowave USA, LLC in this matter.
4. That all conditions precedent to confirmation of the Award by this Court have been met: (1) more than 90 days have elapsed since the date of the Award; (1) there are no grounds to vacate, modify or correct the Award pursuant to Sections 10 and 11 of the Federal Arbitration Act, 9 U.S.C. §§ 10-12 and the Nebraska Uniform Arbitration Act §§ 25-2601, *et seq.* and; (3) the deadline for filing a motion to vacate, modify, or correct the Award has passed

pursuant to Section 12 of the Federal Arbitration Act, 9 U.S.C. § 12 and Neb. Rev. Stat. §§ 25-2613 and 25-2614.

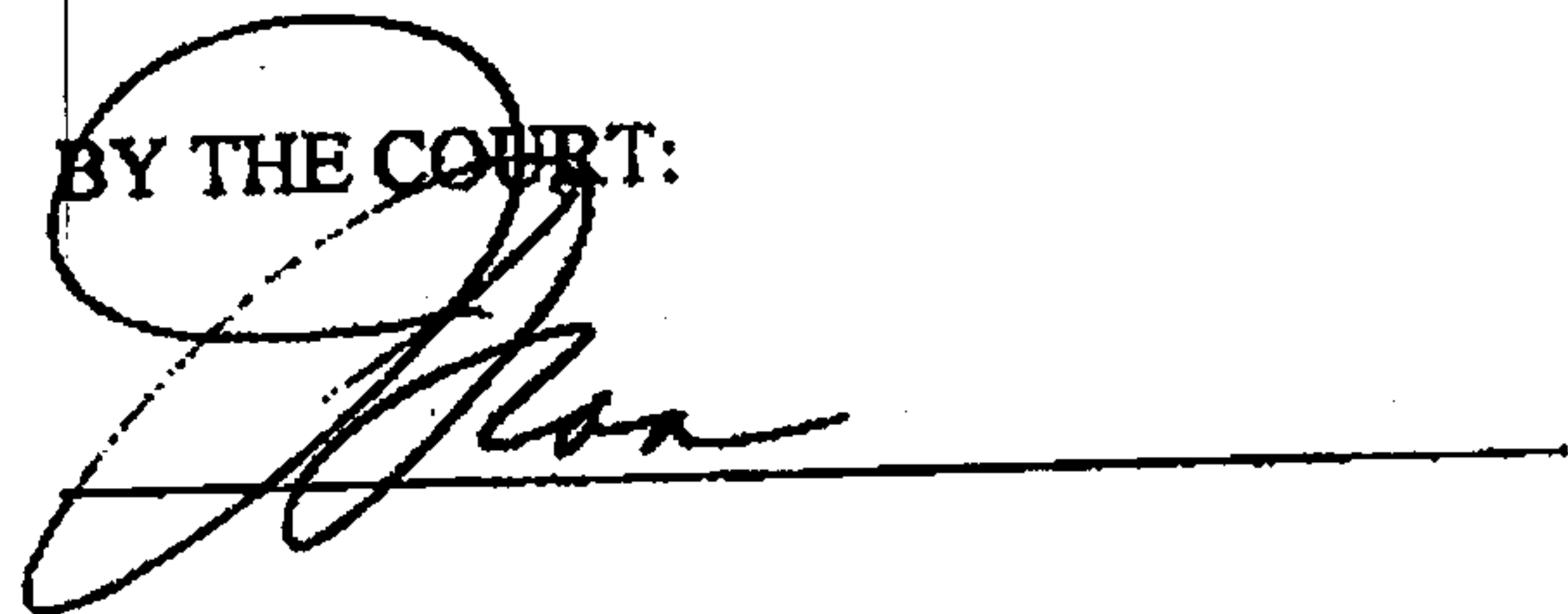
5. That on the basis of the Federal Arbitration Act, 9 U.S.C. §§ 1-14, and the Nebraska Uniform Arbitration Act, Neb. Rev. Stat. §§ 25-2601, et seq., the Award should be and hereby is confirmed.

6. That judgment should be entered in favor of the Plaintiff Innowave USA LLC and against the Defendant Aquapure Water Systems, LLC, for \$25,815.43 plus \$1,825.00 in fees, interest at the legal rate of interest, and expenses and costs in collecting upon this judgment.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that judgment is entered in favor of Innowave USA LLC and against Aquapure Water Systems, LLC in the amount of \$27,640.43, plus post-judgment interest at the legal rate and expenses and costs in collecting upon this judgment.

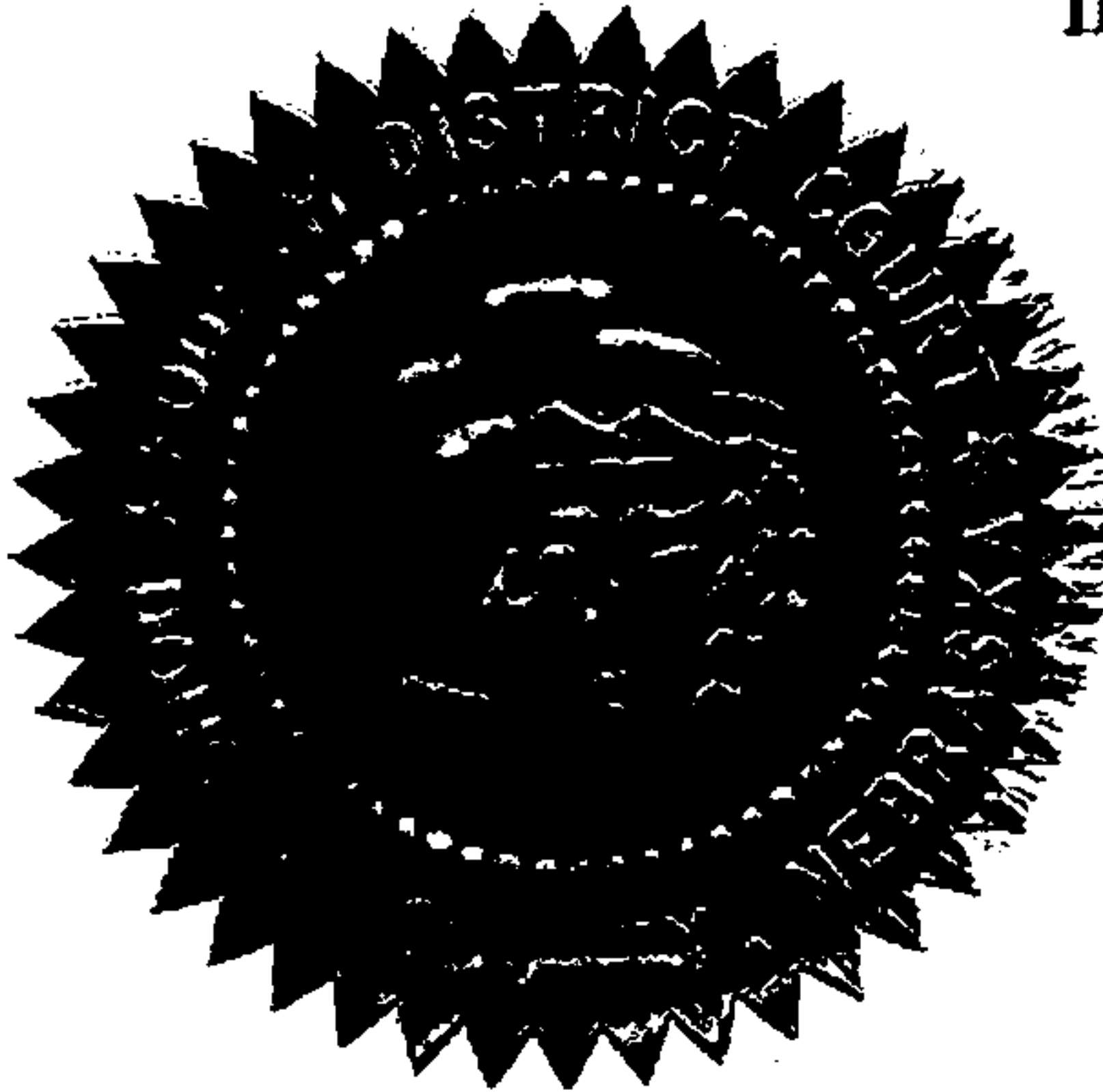

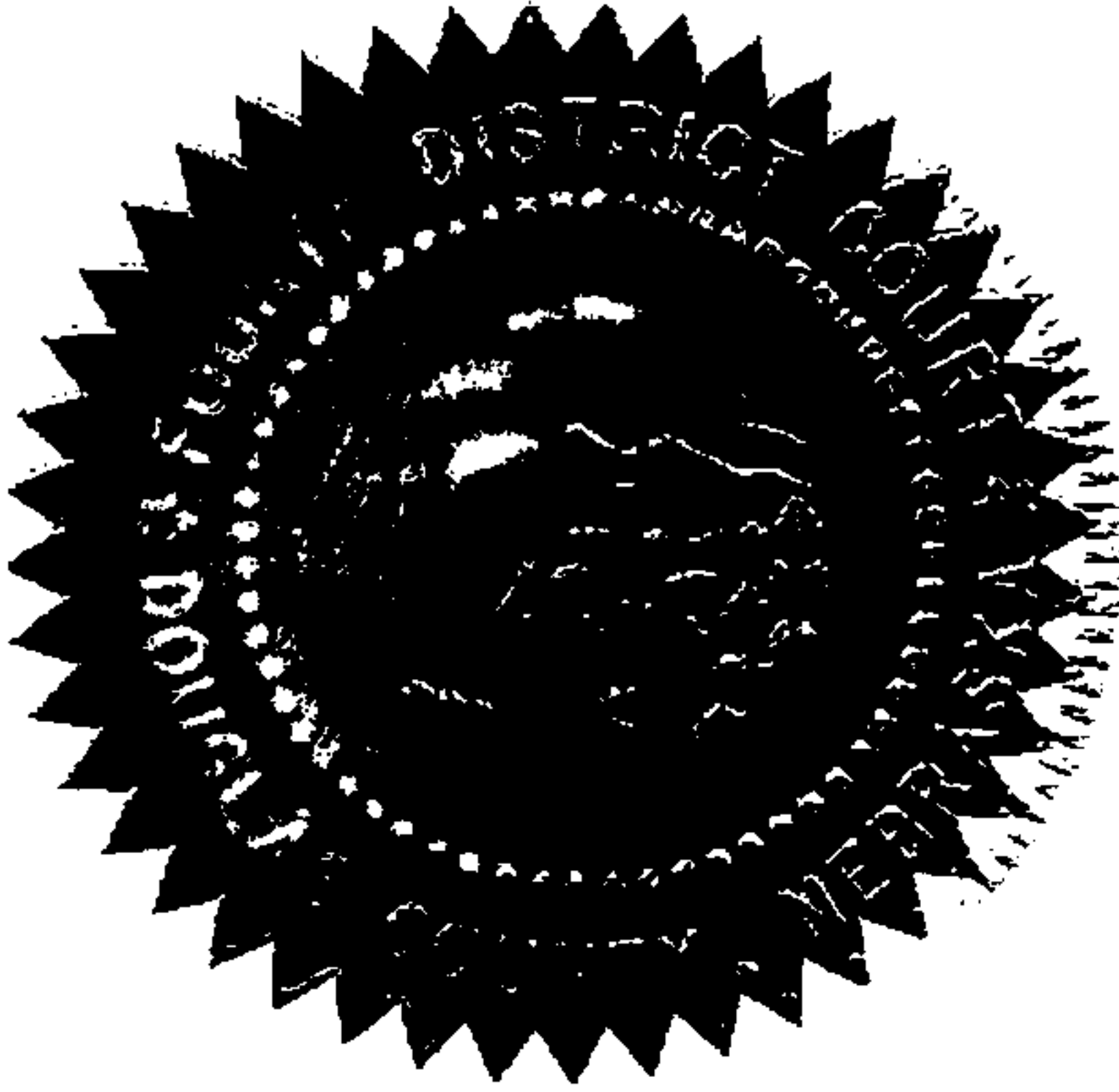

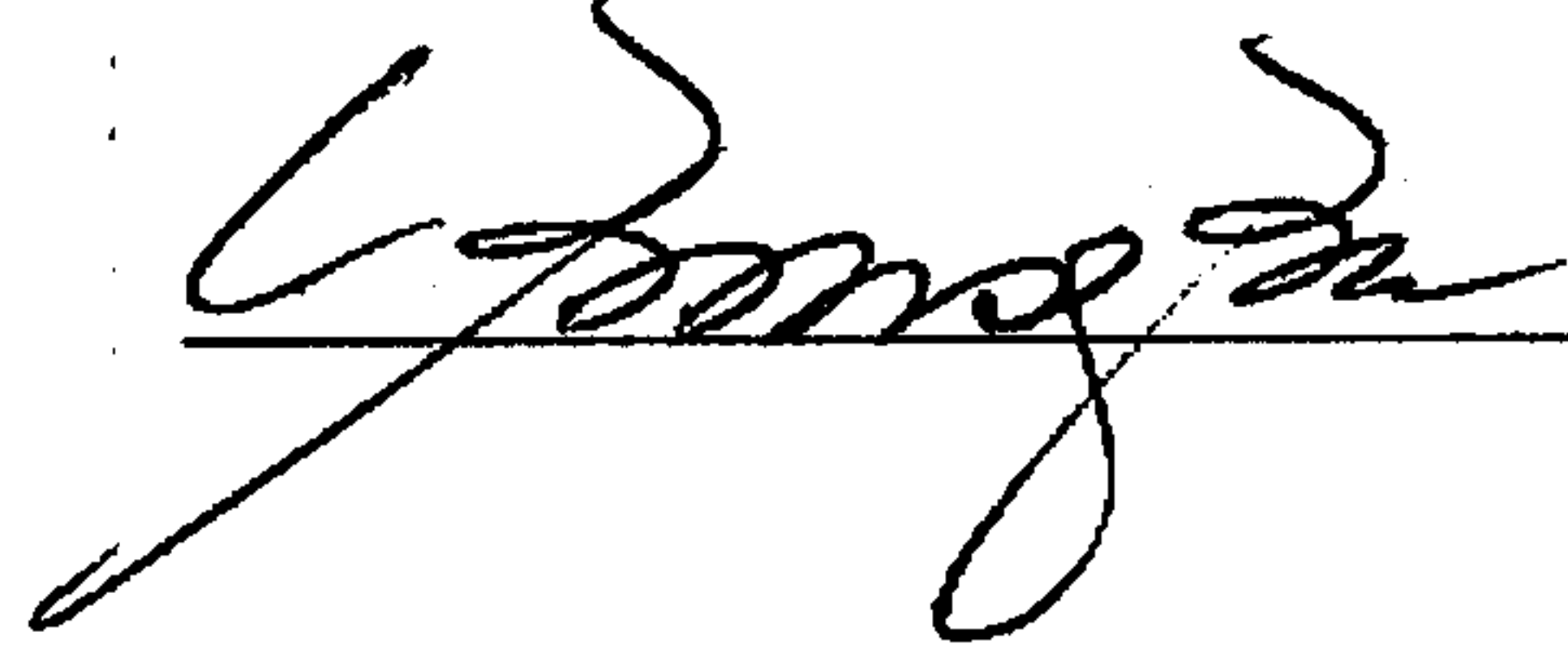
