4. Sewer and utility easement as recorded in Inst. No. 2003-71329.

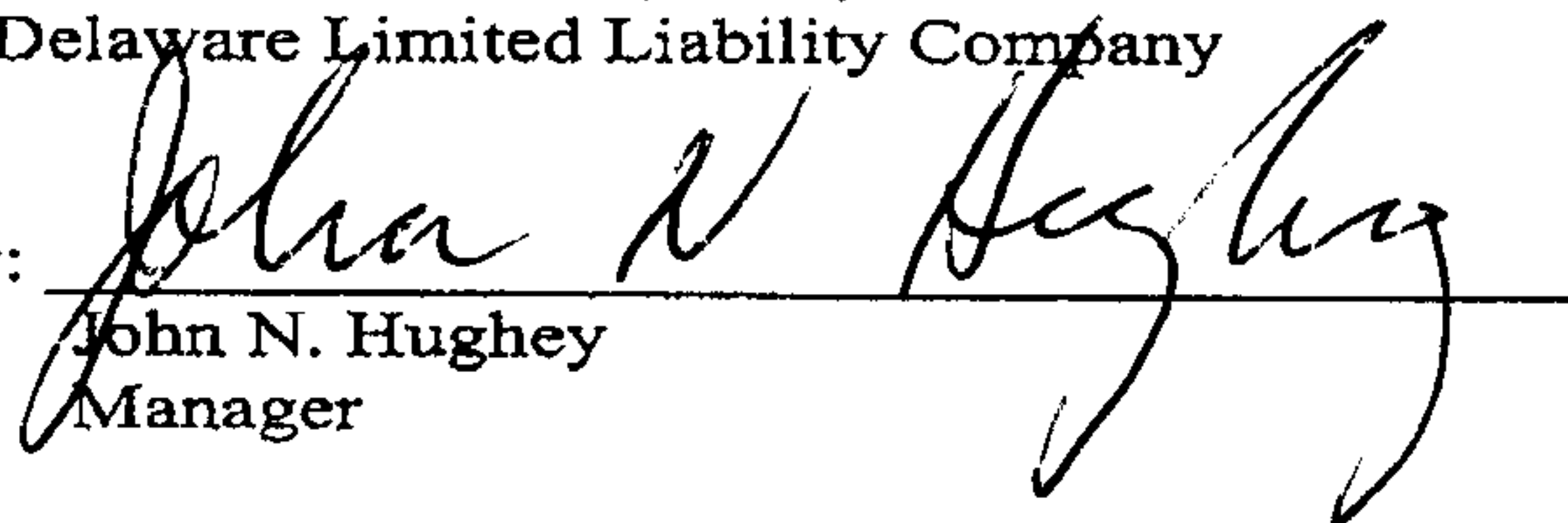

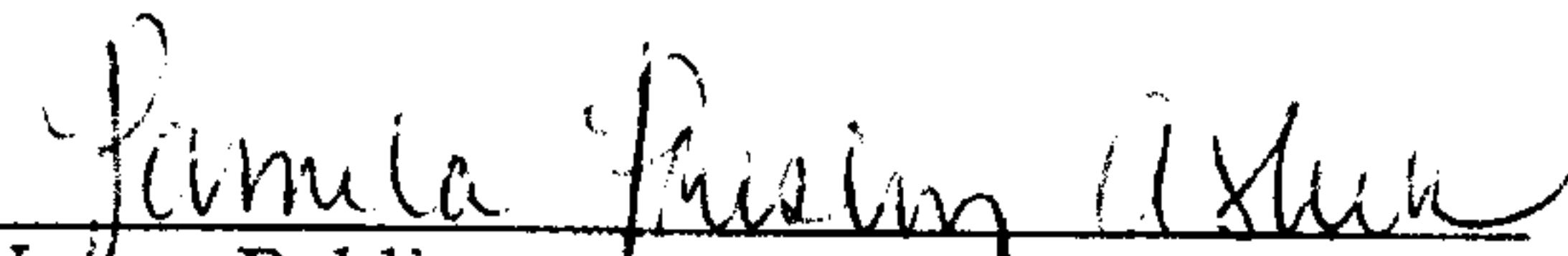
