KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 7th day of February, 2007, Timothy M. Hill, a married man and Sondra R. 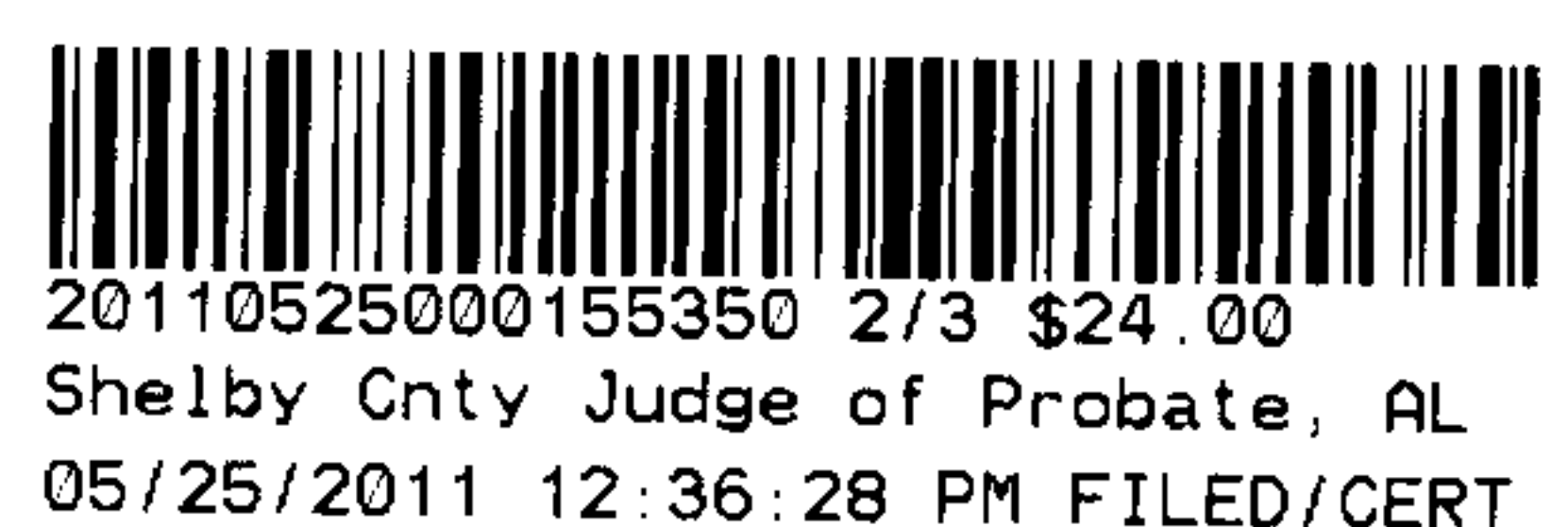
