FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 9th day of February, 2006, Matthew J. McGaha and Erin M. Guyer, Joint Tenancy, both unmarried, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Southstar Funding, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20060215000077100; having been modified in Instrument Number 20090707000259620 and Instrument Number 20090707000259630, said mortgage having subsequently been transferred and assigned to Bank of America, National Association as successor by merger to LaSalle Bank National Association, as Trustee under the Pooling and Servicing Agreement dated as of May 1, 2006, GSAMP Trust 2006-HE3, by instrument recorded in Instrument No. 20110307000075210, in the aforesaid Probate Office ("Transferee"); and




