(herein referred to as Grantor, whether one or more), grant, bargain, sell, and convey unto

TED CROCKETT AND JAMIE G. CROCKETT, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE CROCKETT LIVING TRUST, DATED MAY 23, 2011 AND ANY AMENDMENTS THERETO

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

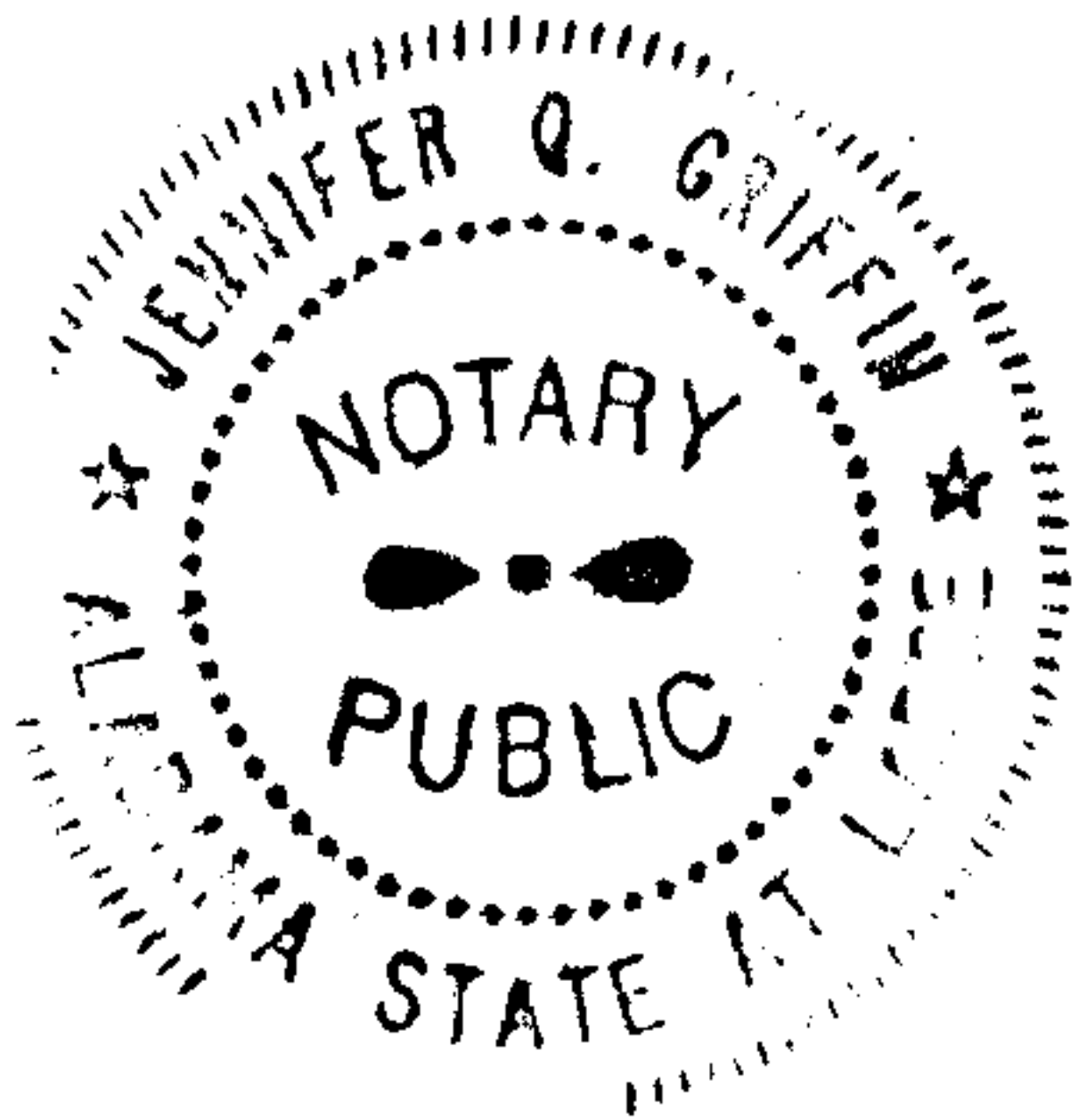
