KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 8th day of June, 2007, Joseph Linton and Jana Linton, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Primary Capital Advisors LC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20070611000272140, said mortgage having subsequently been transferred and assigned to Saxon Mortgage Services, Inc., by instrument recorded in Instrument No. 20100614000188940, in the aforesaid Probate Office ("Transferee"); and


