

CERTIFICATE OF FORMATION

OF

ARTICLE I

NAME

TYPE OF ENTITY

The entity shall be a limited liability company.

ARTICLE III

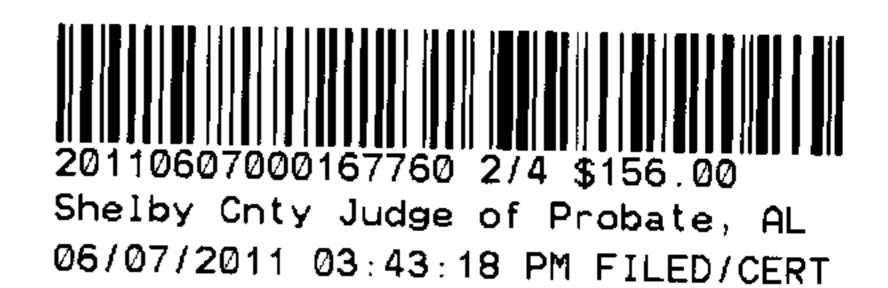
DURATION

Subject to any provisions in the operating agreement of the Limited Liability Company, or the provisions of the Alabama Limited Liability Company Law restricting or enlarging the management rights and duties of any person or group or class of persons, the managers shall have the right and authority to manage the business or affairs of the Limited Liability Company and to make all decisions with respect thereto.

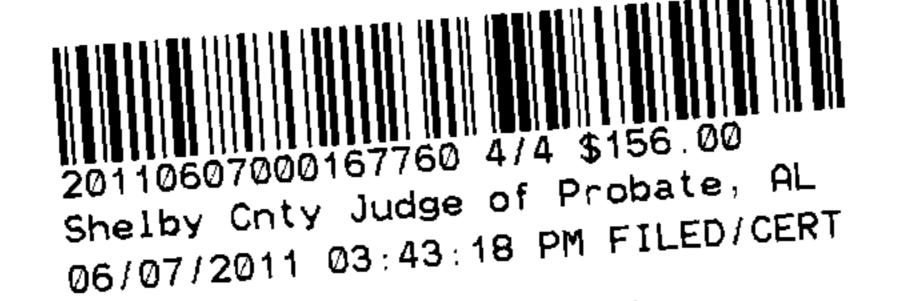
