KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 4th day of March, 2004, Vincent J. Marshall and Cindy M. Marshall, husband and wife, executed that certain mortgage on real property hereinafter described to National City Mortgage Co d/b/a Accubanc Mortgage, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20040308000117910, and

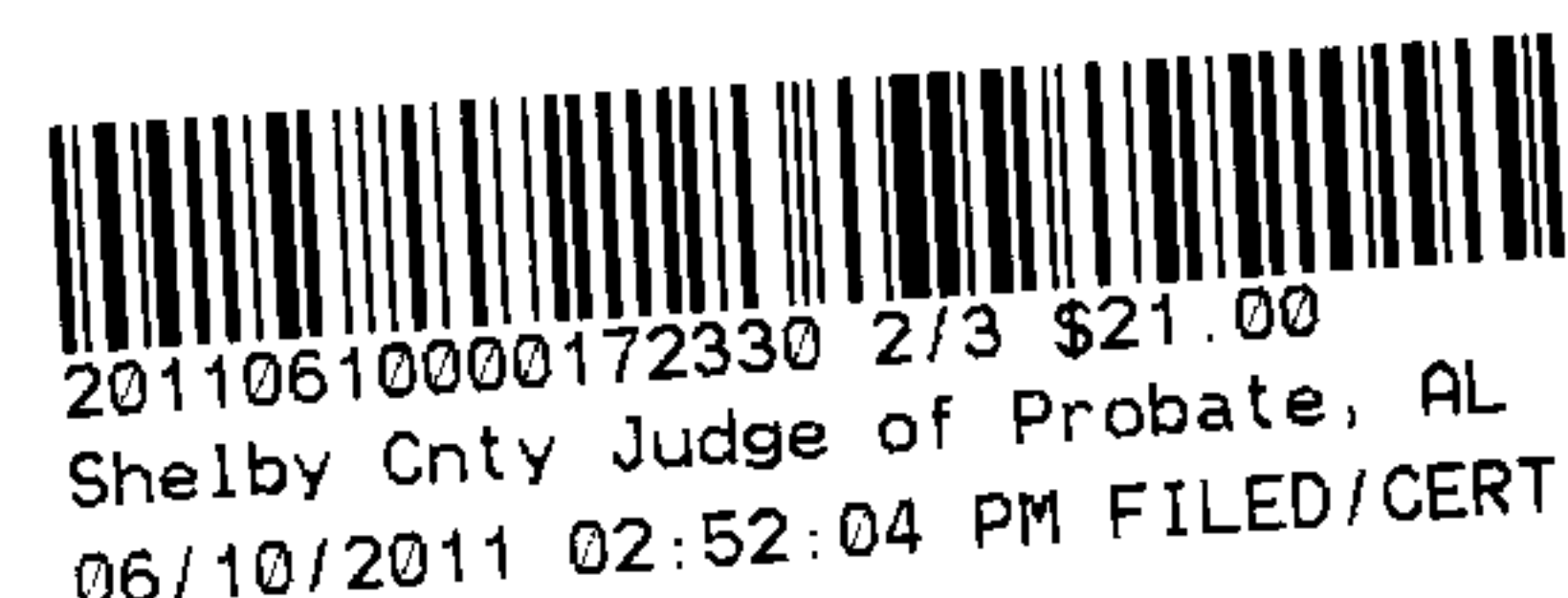

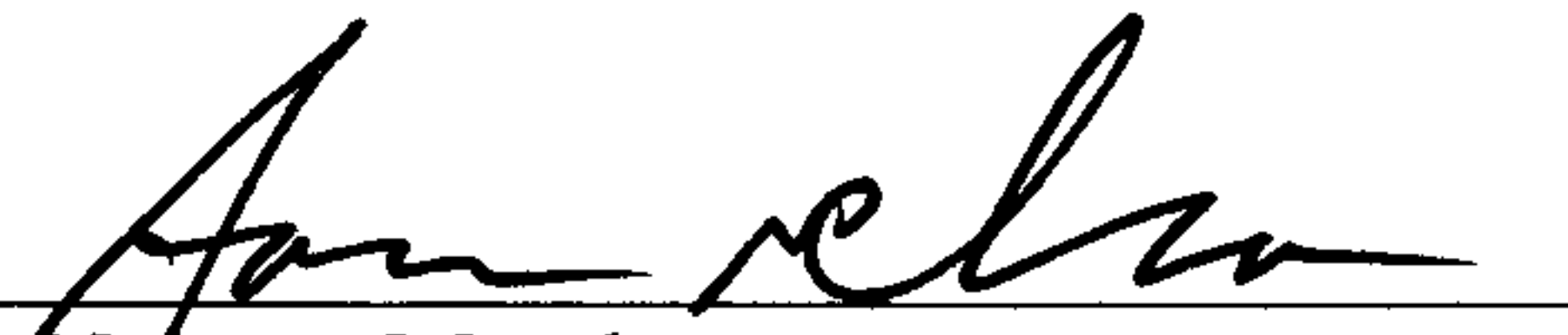

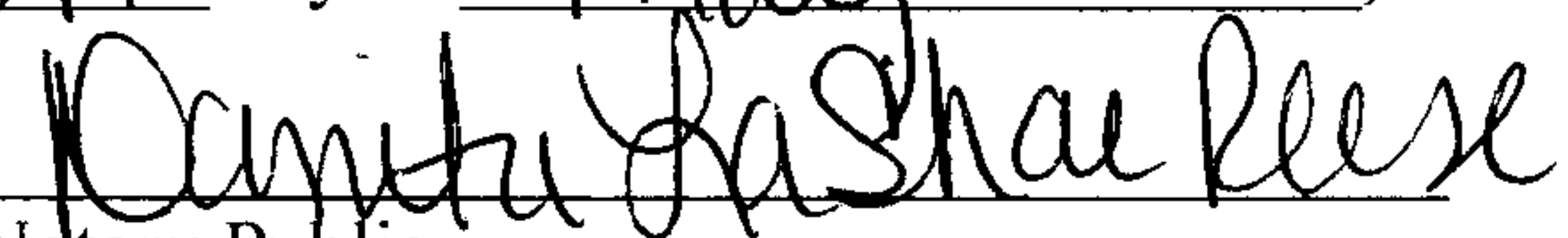
