## WARRANTY DEED

Mark Bahakel, wife and husband (hereinafter referred to as GRANTORS), do hereby grant, bargain, sell and convey unto Phyllis Kollars (hereinafter referred to as the GRANTEE), the following described real estate situated in the County of Shelby and State of Alabama, to-wit:
