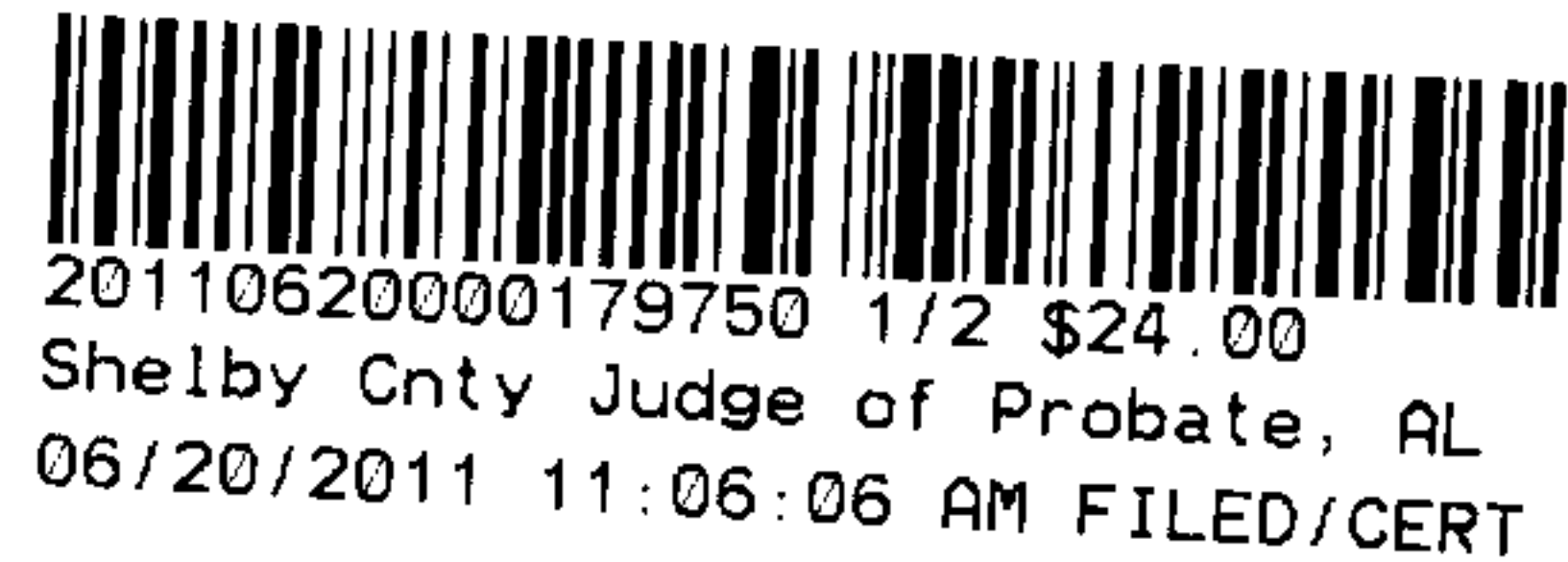


## NOTARY BOND

Does hereby constitute and appoint Jim House

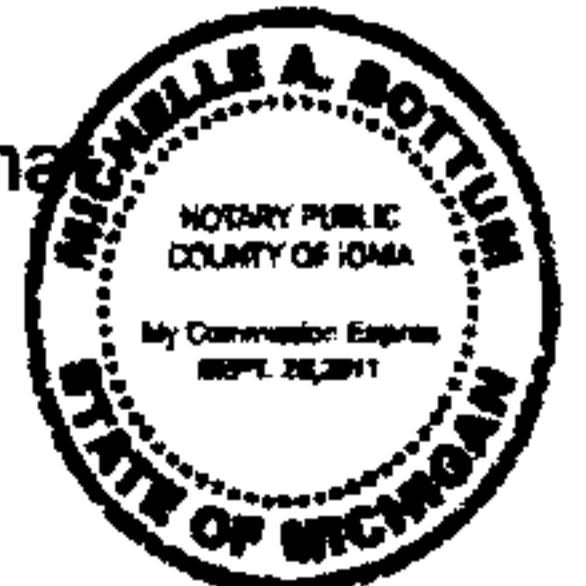
