

CERTIFICATION OF FORMATION OF

BULTRUST ALABAMA LLC, an Alabama Limited Liability Company

Pursuant to the Code of Alabama § 10A-1-1.01, et seq. (the "Act"), the undersigned hereby adopts the following Certification of Formation:

ARTICLE I NAME

The name of the limited liability company (the "Company") is "BULTRUST ALABAMA LLC".

ARTICLE II DURATION

The existence of the Company shall be perpetual.

ARTICLE III PURPOSES

The Company's purpose is to own and manage real properties and to do everything necessary, proper, advisable or convenient for the accomplishment of such purposes and to do all other things incidental to such purposes or in connection with such purposes that are not prohibited by law. In extension and not in limitation of the purposes specifically enumerated, the Company is authorized and empowered to engage in any lawful business in which limited liability companies may engage under the Act.

ARTICLE IV INITIAL REGISTERED OFFICE AND AGENT



Any amendment to this Certificate of Formation shall require approval of all members.


ARTICLE IX CONTINUATION UPON WITHDRAWAL OF MEMBER

The existence of the Company shall continue upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or occurrence of any event which terminates the continued membership of a member in the Company (collectively, "Cessation of Membership") as long as there is at least one remaining member and that member carries on the business of the Company (any such remaining member being hereby authorized to carry on the business of the Company), or, within ninety (90) days after the Cessation of Membership of the last member, all of the holders of the financial rights in the Company agree in writing to continue the legal existence and business of the Company and to the appointment, effective as of the date of such event, of one or more additional members.

ARTICLE X LIABILITIES OF MEMBERS AND MANAGERS

Members and managers of the Company are not liable under a judgment, decree or order of a court, or in any other manner, for a debt, obligation or liability of the Company, whether arising in contract, tort, or otherwise, or for the acts or omissions of any other member, manager, agent or employee of the Company.


