FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 20th day of August, 2007, Kathy Hume Clifton, a single woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Hometown Mortgage Services, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070824000399020, said mortgage having subsequently been transferred and assigned to Flagstar Bank, FSB., by instrument recorded in Instrument No. 20110415000117470, in the aforesaid Probate Office ("Transferee"); and

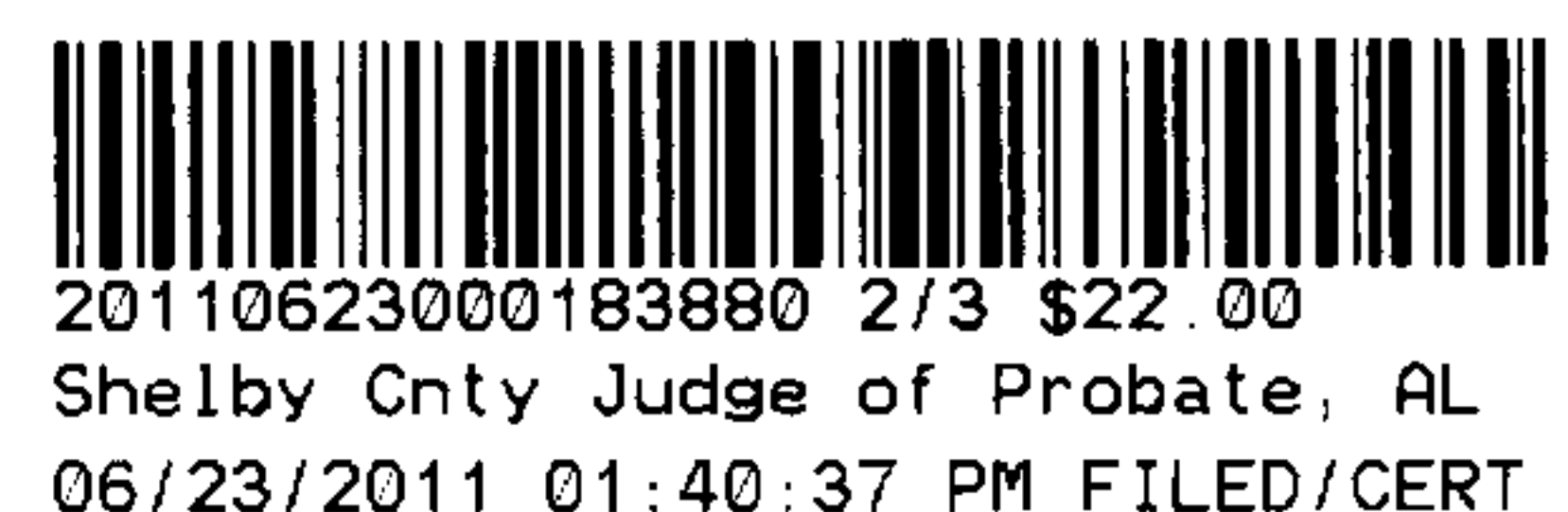
