FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 3rd day of April, 1998, Randolph L. Wilson and Denise L. Wilson, Husband and Wife, executed that certain mortgage on real property hereinafter described to Coats & Co., Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 1998-13210, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc., by instrument recorded in Instrument Number 20110223000062520, in the aforesaid Probate Office ("Transferee"); and

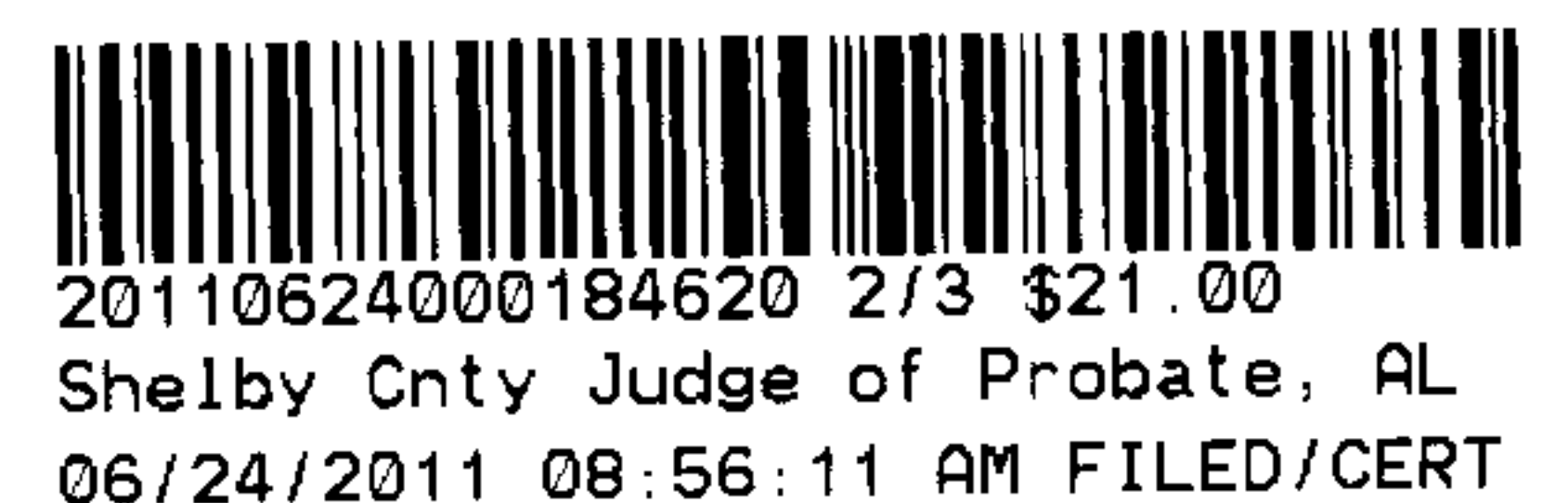
