

ORCUTT, the receipt of which is hereby acknowledged, I, GRACIE H. CHERRY, as Personal Representative aforesaid, do hereby grant, bargain, sell and convey unto JACK W. ORCUTT the following described parcel of real estate, which was the property of JIMMIE COSPER HARRISON, to-wit:

A parcel in part of the Southwest Quarter of the Northeast Quarter and in part of the Northwest Quarter of the Southeast Quarter of Section 12, Township 18 South, Range 1 East in Shelby County, Alabama and being more particularly described as follows: Commence at an existing 1" pipe at the Southwest corner of the Northwest Quarter of the Southeast Quarter and run North 00°15' East along the West line of said quarter-quarter section for 855.46 feet to an existing 5/8" rebar; thence North 00°22'25" East along said West line for 705.63 feet to an existing ½" rebar on the South right-of-way of Shelby County Highway #43 (80' right-of-way); thence South 89°11'40" East along said South right-of-way for 337.94 feet to a 5/8" rebar set at the Point of Beginning.
