Commence at a ½" rebar in place accepted as the Northwest corner of the Southwest ¼ of the Southeast ¼ of Section 11, Township 20 South, Range 2 East, Shelby County, Alabama; thence proceed South 02 degrees 15 minutes 30 seconds West along the West boundary of said Quarter Quarter section for a distance of 714.60 feet to the point of beginning. From this beginning point proceed North 65 degrees 45 minutes 42 seconds East for a distance of 836.86 feet to a point on the Westerly right of way of Shelby County Road No. 79; thence proceed South 25 degrees 21 minutes 53 seconds East along the Westerly right of way of said road for a distance of 181.86 feet; thence proceed South 71 degrees 43 minutes 03 seconds West for a distance of 889.86 feet to a point on the West boundary of said Quarter-Quarter section; thence proceed North 02 degrees 15 minutes 30 seconds East along the West boundary of said Quarter-Quarter section for a distance of 100.0 feet to the point of beginning.
