\$56,950.00 of the consideration was paid from the proceeds of a mortgage loan.

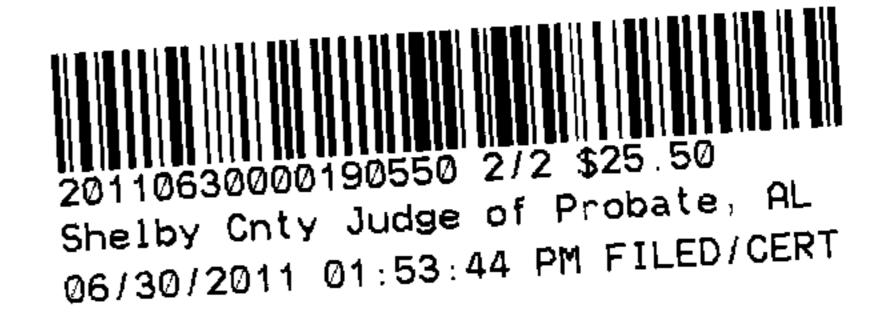
