AMENDMENT TO OPEN-END CREDIT, FUTURE ADVANCE REAL ESTATE MORTGAGE AND SECURITY AGREEMENT

This Amendment (the "Amendment") is made and entered into on <u>June 20</u>, <u>2011</u>, by and between <u>Donald Keith Owens AKA Donald K Owens A Married Man and Kimberly M Owens His Wife</u> (hereinafter called the "Mortgagor", whether one or more) and First Commercial, a division of Synovus Bank (hereinafter called the "Mortgagee").

RECITALS

- D. The Mortgagee has required, as a condition to approving the request for the Amended Credit Limit, that the Mortgagor enter into this Amendment.

Except as specifically amended hereby, the Mortgage shall remain if full force and effect in accordance with its terms.
