
Articles of Organization Of Nicolaou Design and Technology, L.L.C.

The undersigned, acting as the organizer of a limited liability company under the Alabama Limited Liability Company Act (the "Act"), hereby adopt the following Articles of Organization for Nicolaou Design and Technology, L.L.C.

Article One

The name of the Company is Nicolaou Design and Technology, L.L.C. (herein the "Company"), an Alabama Limited Liability Company.


