ARTICLE I NAME

The name of the limited liability company (the "Company") is:

The existence of the Company shall be perpetual, or until terminated by agreement of the member or members or by operation of law.

ARTICLE III PURPOSES

ARTICLE VII MANAGEMENT

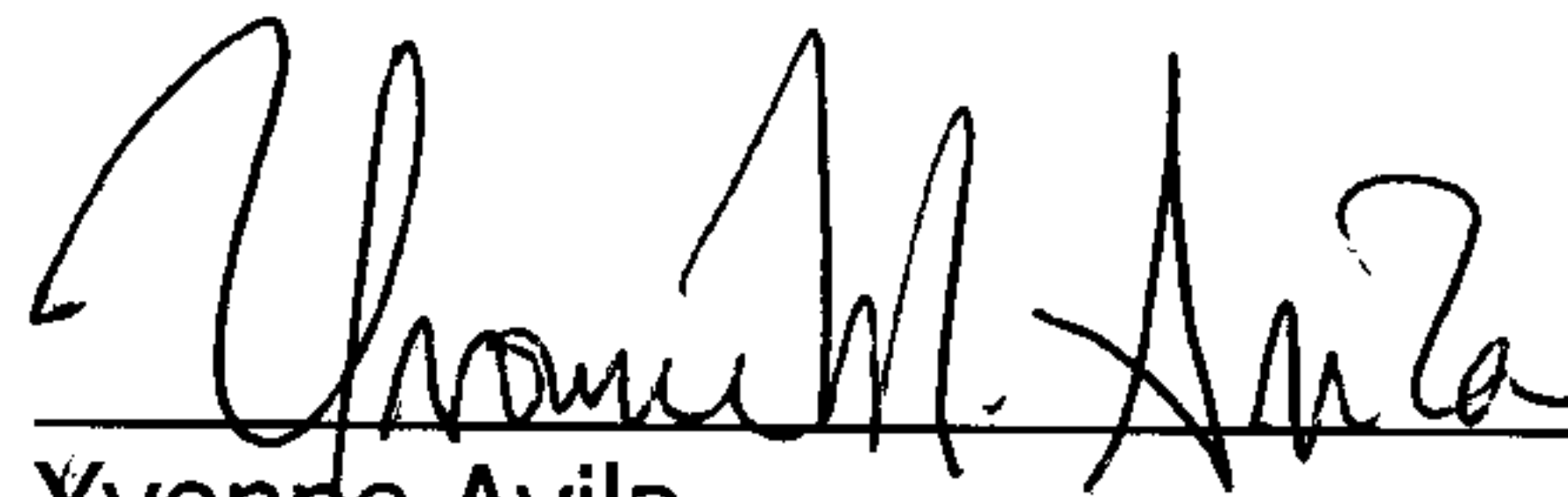
The Company shall be managed by the member or members.

These Articles of Organization are executed by the organizing member as of May 3, 2011.

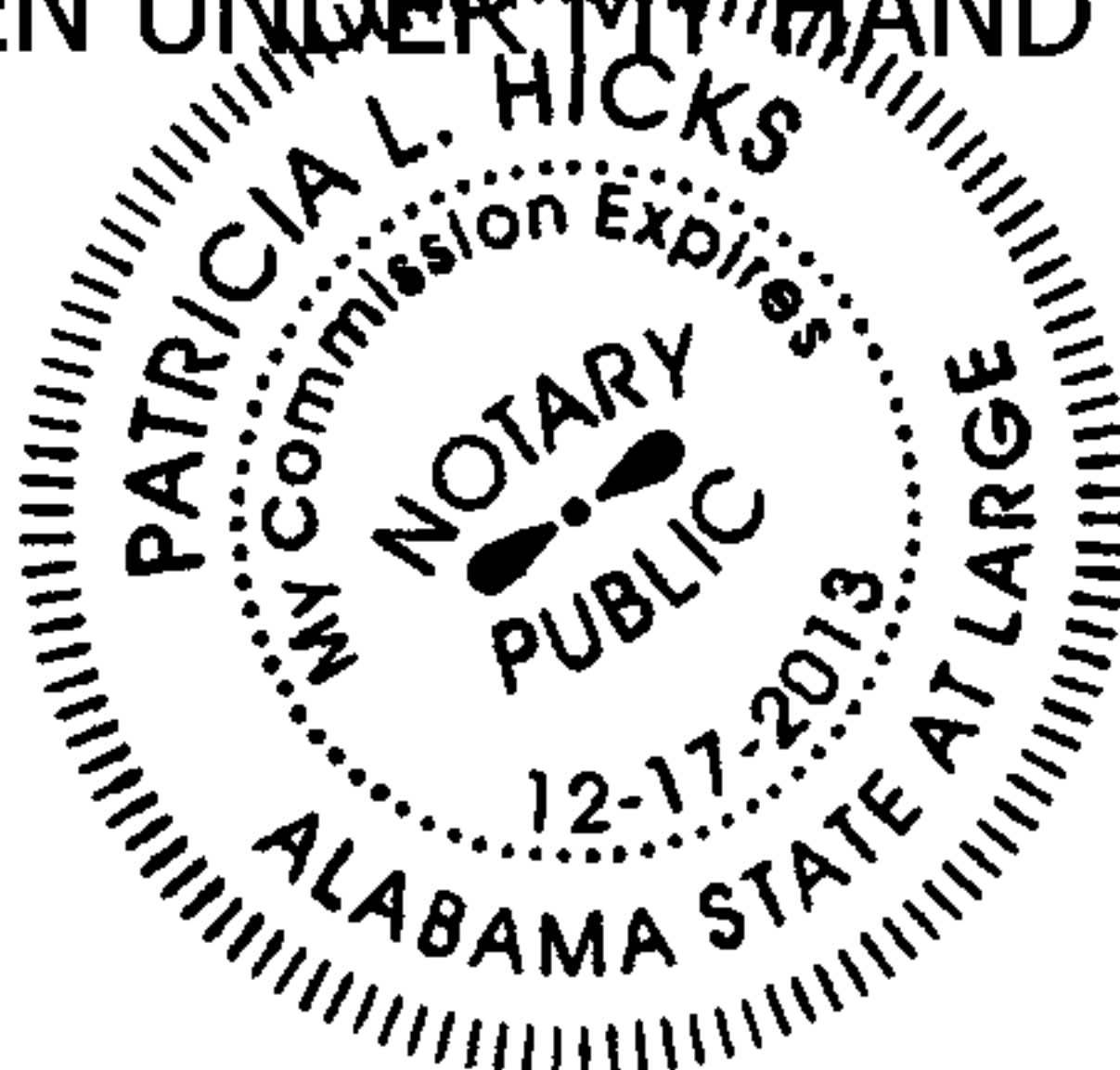

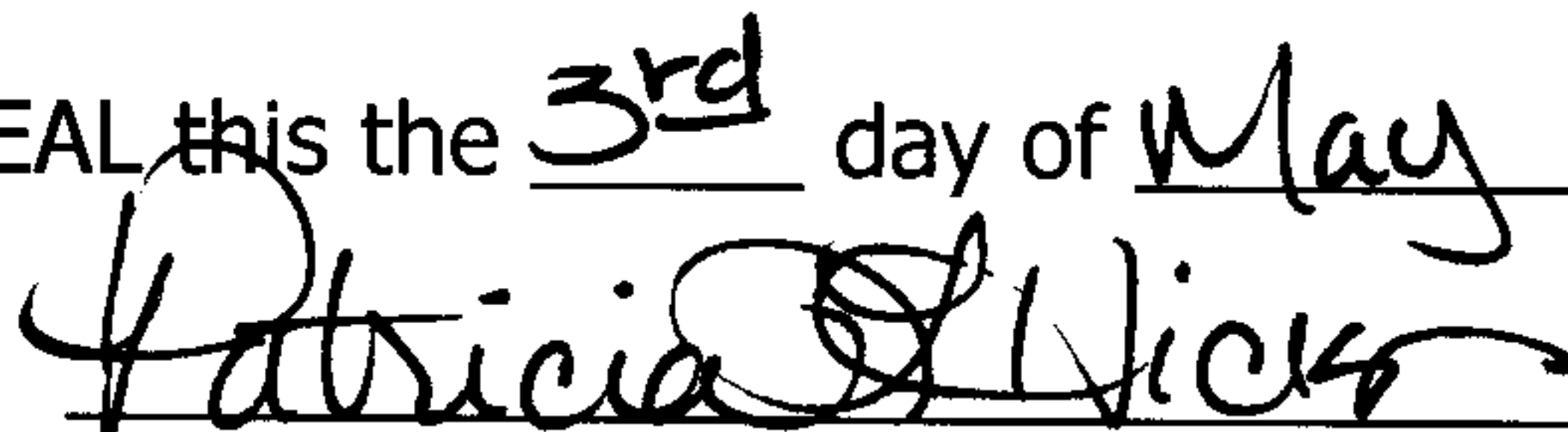
