## LIMITED POWER OF ATTORNEY


Beal Bank (the "Bank") may transfer those certain loans (including residential mortgage loans, residential construction loans and commercial loans), judgments and other assets with an unpaid principal balance of less than \$29 million which are owned by the Bank (the "Loans") and listed on Exhibit A attached hereto, to its subsidiary, Property Acceptance Corp. ("PAC"). In order to facilitate the transfer of such Loans, the Bank hereby constitutes and appoints W.T. Saurenmann, Senior Vice President of Beal Service Corporation, and James Erwin, Senior Vice President of Beal Nevada Service Corporation, acting alone (provided that such person continues to hold the respective corporate office), as its true and lawful attorney-in-fact, and in its name, place and stead and for its use and benefit, to execute certain assignments, allonges or endorsements for the limited purpose of transferring the Loans from the Bank to PAC.

The undersigned gives to said attorney-in-fact full power and authority to execute such instruments for the limited purpose described above and to carry into effect the power or powers granted by or under this Limited Power of Attorney as fully, to all intents and purposes, as the undersigned might or could do, as if the undersigned were personally present. This Limited Power of Attorney is executed and is effective as of this 18<sup>th</sup> day of April 2011. This Limited Power of Attorney shall expire and be of no further force or effect on and after April 18, 2012. Notwithstanding anything to the contrary herein, this Limited Power of Attorney may be revoked at anytime.
