

**ARTICLES OF ORGANIZATION
OF
COMPLETE TITLE SERVICES LLC**

The undersigned, being a natural person of at least 19 years of age and acting as the Organizer of the Limited Liability Company hereby being formed under the Alabama Code Sections 10-12-1 to 12-12-61, does hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

COMPLETE TITLE SERVICES LLC

SECOND: The Limited Liability Company shall continue until the occurrence of an event set forth in the Operating Agreement which causes the termination of the Limited Liability Company.

THIRD: The Limited Liability Company is organized for the following purposes: As a Title Company and to carry on any other activities necessary to, in connection with or incidental to the foregoing, as the Managing Member in his discretion may deem desirable.

FORTH: The street address of the initial registered office of the Limited Liability Company in Alabama is 2100 Riverchase Center Suite 100, Birmingham, Alabama 35244, and the name of the initial registered agent of the Limited Liability Company in Alabama at that address is Mike Giles

FIFTH: The principal office of the Limited Liability Company is 2100 Riverchase Center Suite 100, Birmingham, Alabama 35244.

SIXTH: The Limited Liability Company is to be managed by a managing Member. The name and address of the initial Managing Member is: Mike Giles, Managing Member, having an address at 2100 Riverchase Center Suite 100, Birmingham, Alabama 35244. The foregoing Managing Member shall serve as Managing Member until the first annual meeting of the Members or until his Successor is duly appointed.

SEVENTH: The existing Member shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Members, in accordance with the terms and conditions of the Operating Agreement of the Limited Liability Company.

EIGHTH: The remaining Members of the Limited Liability Company, by the affirmative vote or consent of Members holding a majority of the Members' Percentage Interests (other than the Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.

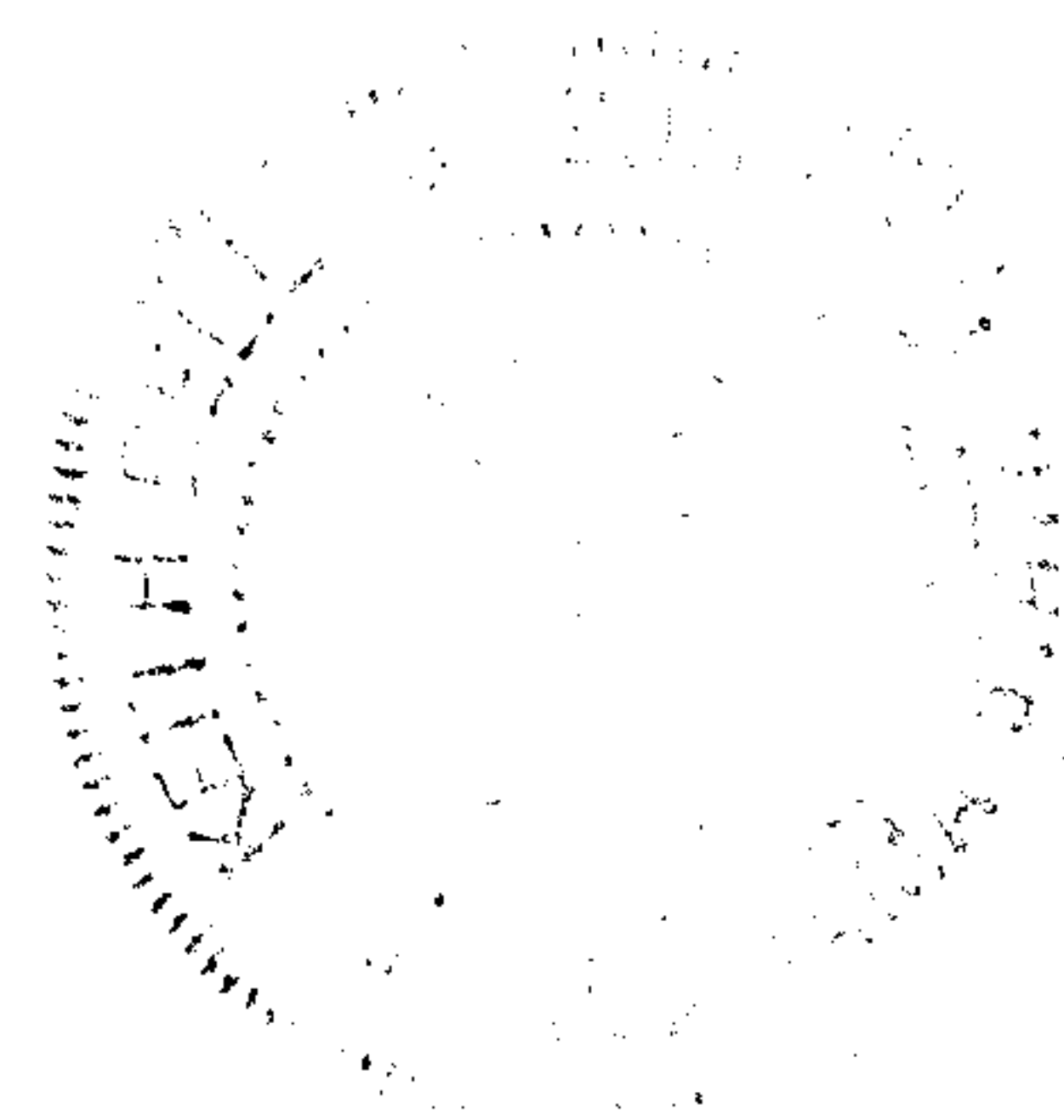
