FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 13th day of September, 2006, Victoria L. Kiser and Matthew A. Kiser, wife and husband, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as a nominee for Quicken Loans, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20060927000479120, said mortgage having subsequently been transferred and assigned to BAC Home Loans Servicing, L.P, by instrument recorded in Instrument Number 20101215000421840, in the aforesaid Probate Office ("Transferee"); and

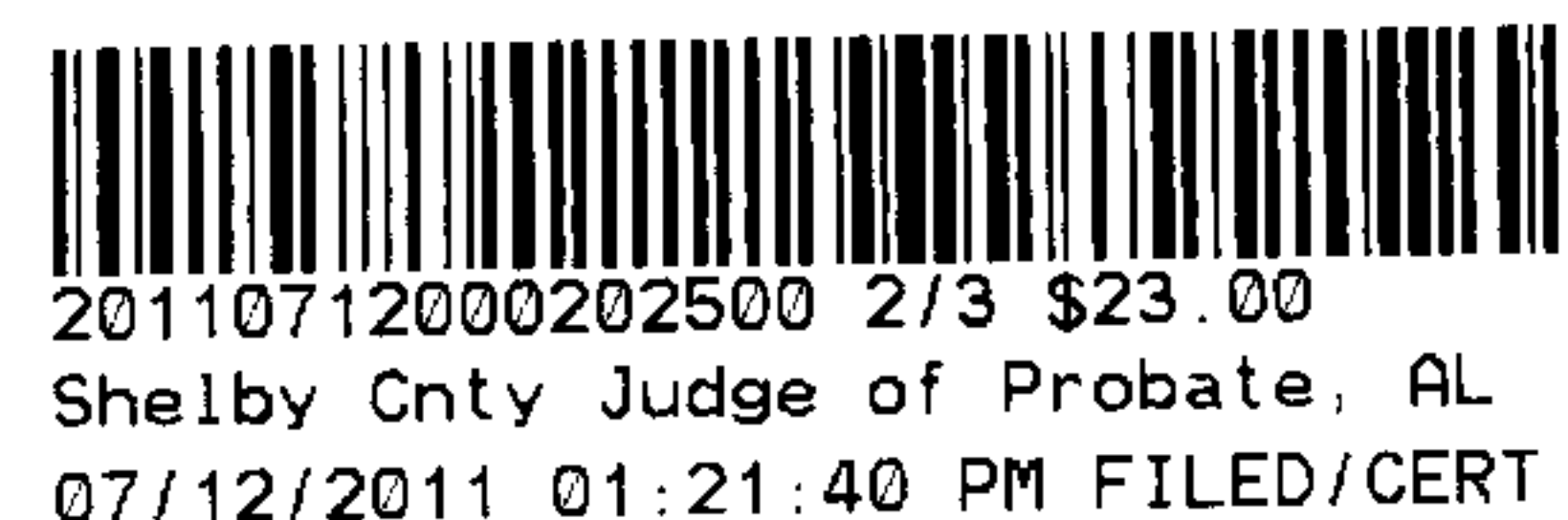

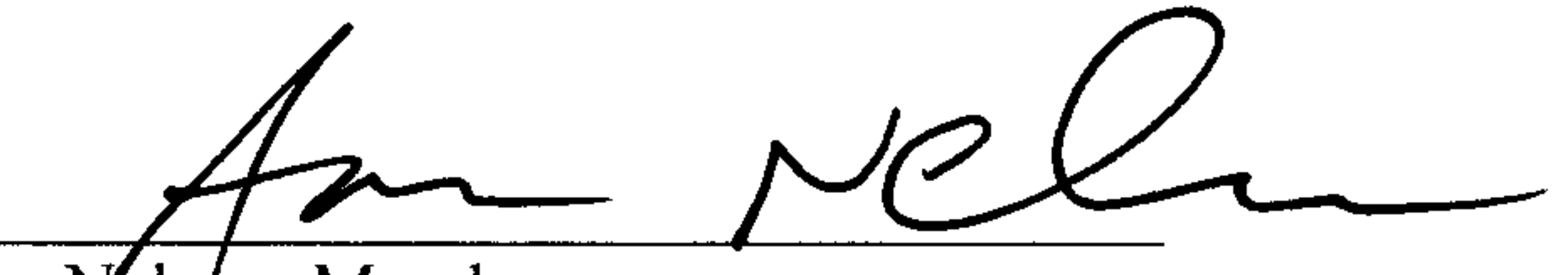

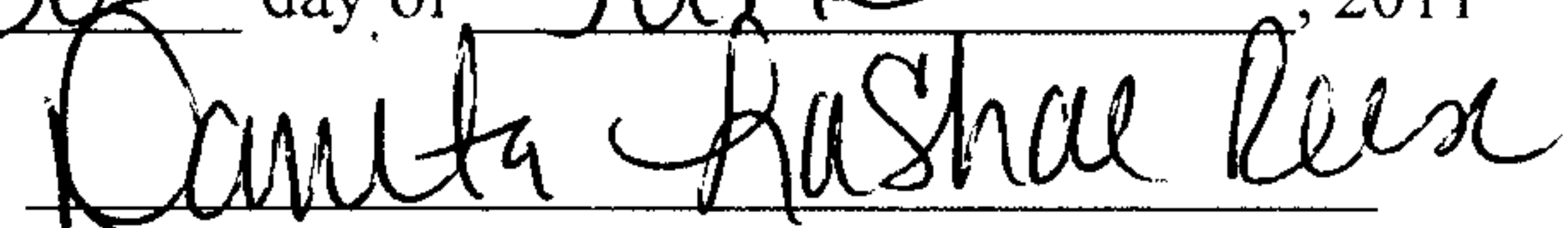
