

ARTICLES OF ORGANIZATION

We, the undersigned, desiring to form a limited liability company pursuant to the laws of the State of Alabama, certify as follows:

Article I: The name of the entity is: TC&T, L.L.C.

Article II: The existence of the limited liability company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and its duration shall be perpetual; provided, however, that the limited liability company shall be dissolved (a) upon the written consent of all of the members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act.

- (3) any other lawful purpose available to an entity of this type.


