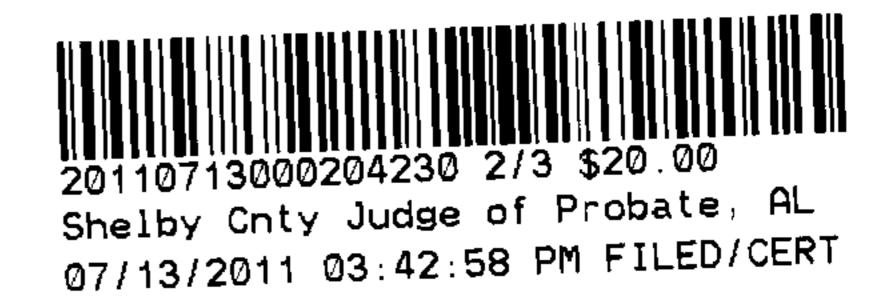

TO HAVE AND TO HOLD unto Grantee and its successors and assigns in fee simple forever.

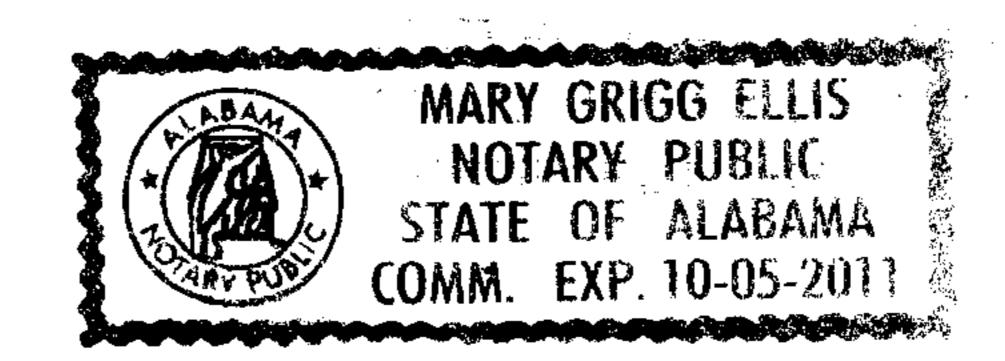
