FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 26th day of September, 2005, Paul G. Contorno and Kelly D. Contorno, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Wachovia Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20051004000516730, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, NA successor by merger to Wachovia Bank, NA, by instrument recorded in Instrument Number 20110502000130800, in the aforesaid Probate Office ("Transferee"); and

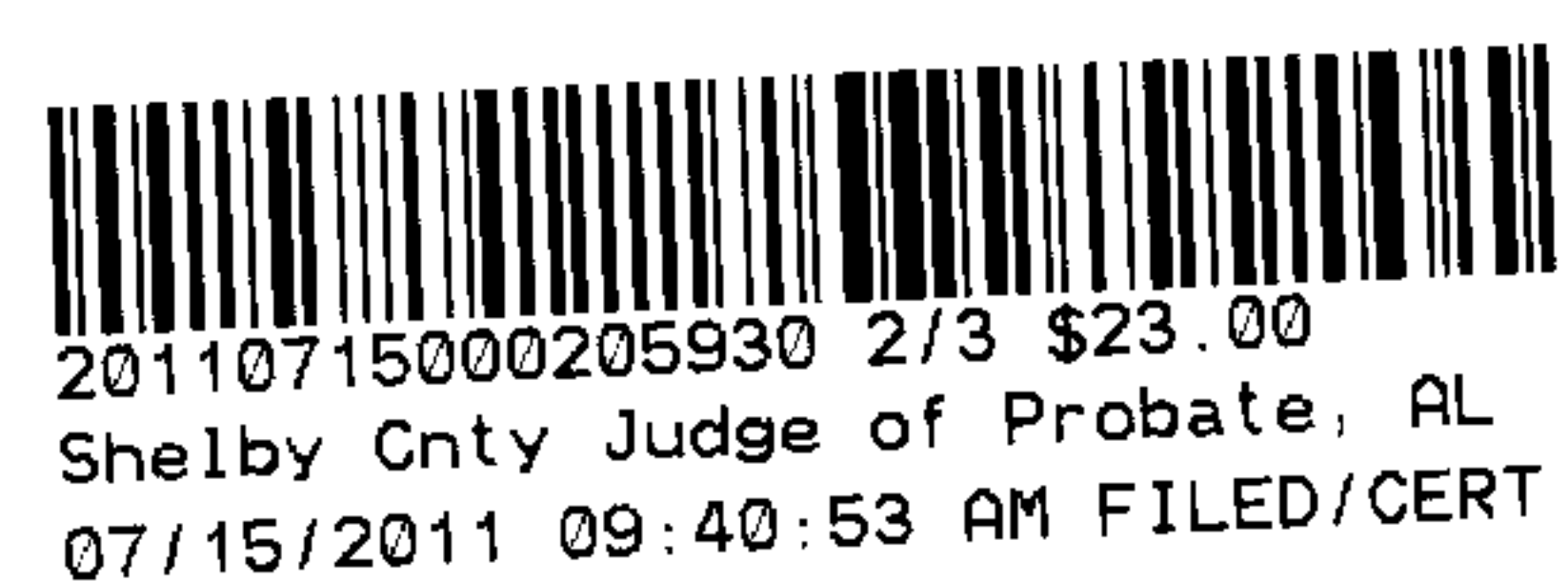




