**ARTICLES OF ORGANIZATION
OF

The undersigned organizer, desiring to form a limited liability company pursuant to the laws of the State of Alabama, certifies as follows:

I. The name of the limited liability company is AB Vestavia, LLC.

II. The existence of the limited liability company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and its duration shall be perpetual; provided, however, that the limited liability company shall be dissolved (a) upon the written consent of all of the members; (b) as provided in the Operating Agreement, if any; or (c) as may be required by the Alabama Limited Liability Company Act.

III. The purpose for which this limited liability company is organized is to engage in the transaction of any or all lawful business for which limited liability companies may be organized under the laws of the State of Alabama.

VII. The limited liability company shall be managed by a manager who shall serve as manager until its successor is elected and qualified. The name and mailing address of the initial manager is as follows:

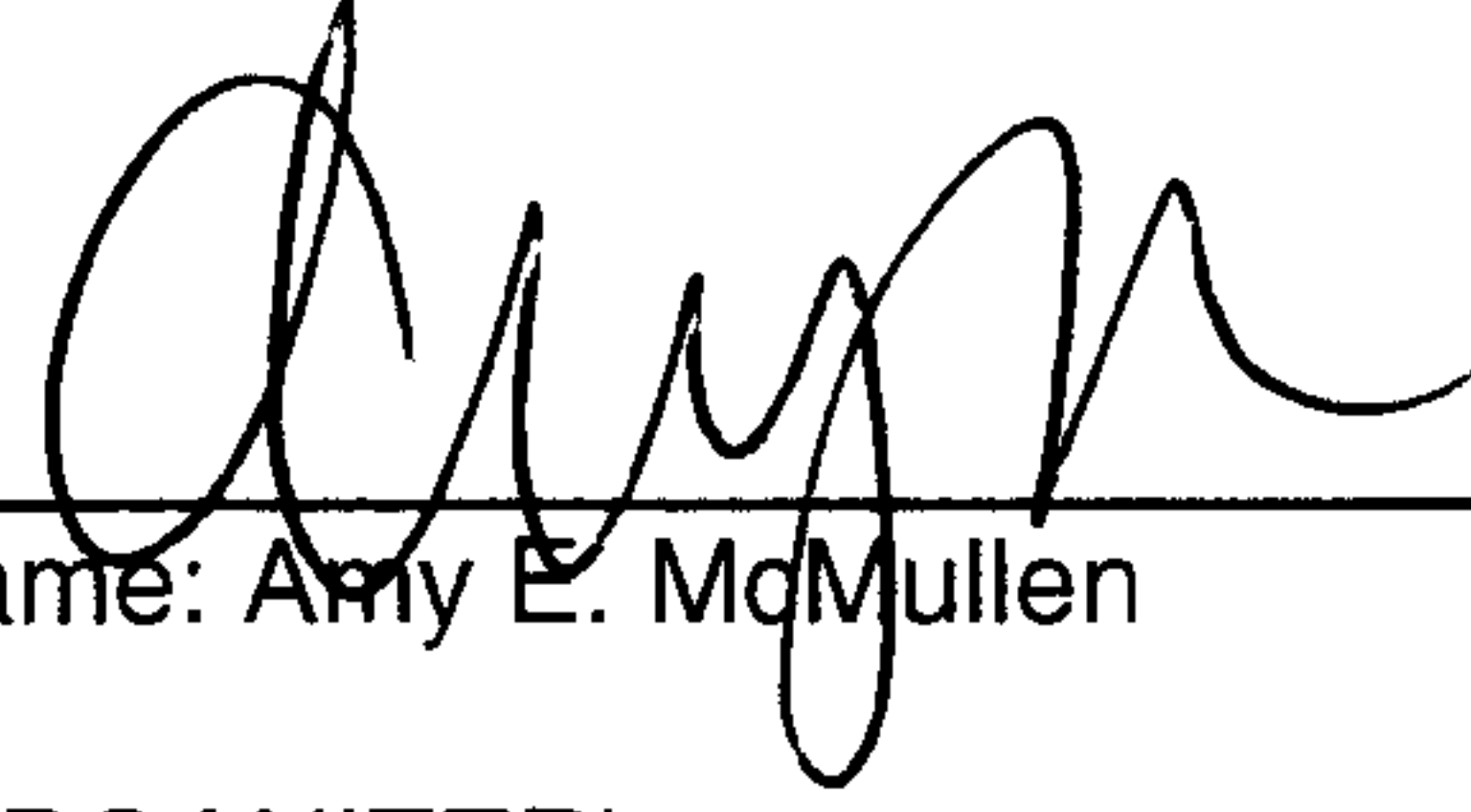
