(herein referred to as Grantor, whether one or more), grants, bargains, sells, and conveys unto

EARNEST L. GILLILAND AND ANN P. GILLILAND, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE EARNEST L. GILLILAND LIVING TRUST, DATED JULY 18, 2011 AND ANY AMENDMENTS THERETO

(herein referred to as Grantee, whether one or more), all my one-half (1/2) interest in the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 30, according to the Survey of Quail Run, Phase 2, as recorded in Map Book 7 page 113 in the Probate Office of Shelby County, Alabama. Subject to taxes, restrictions, rights-of-way, exceptions, conditions, covenants and easements of record.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said **GRANTEE**, his, her or their successors and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said **GRANTEE**, his, her or their successors and assigns forever, against the lawful claims of all persons.


