MODIFICATION OF MORTGAGE

The original Mortgage, Deed of Trust, or Security Deed referenced above secures a home equity revolving line of credit. Notwithstanding anything to the contrary herein, Lender may commence legal proceedings or otherwise proceed against any other party in any other jurisdiction if determined by Lender to be necessary in order to fully enforce or exercise any right or remedy of Lender relating to this loan including without limitation realization upon collateral that secures this loan.


