WILCOX BUILDING COMPANY, LLC

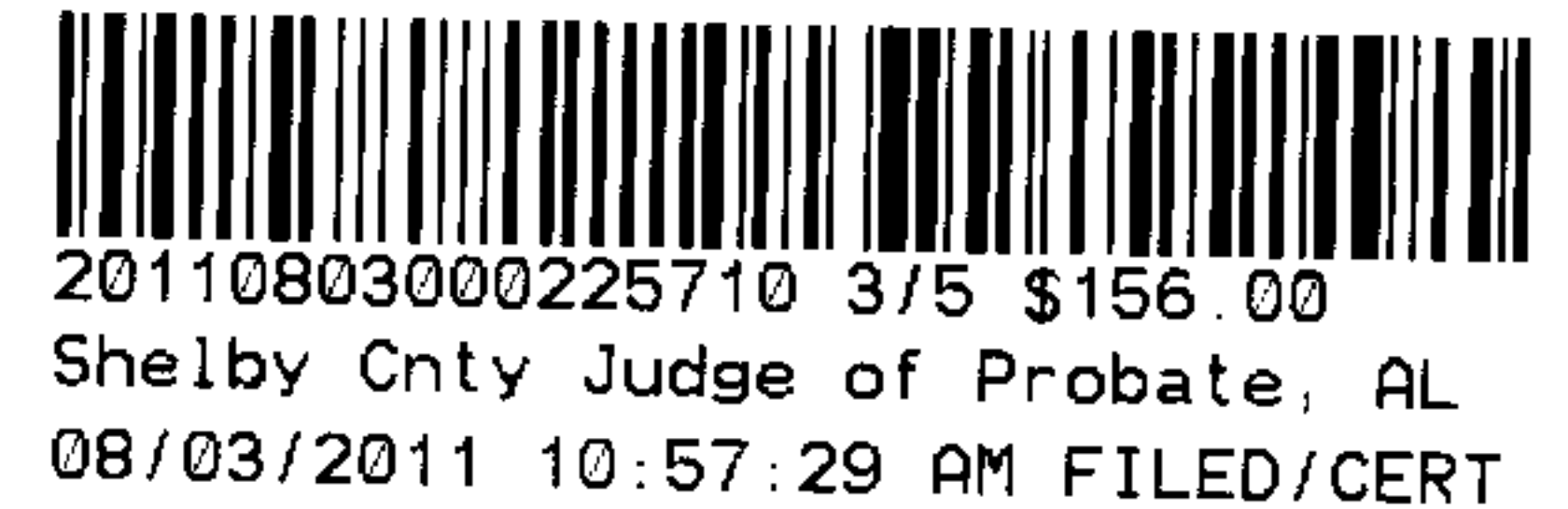
ARTICLE II DURATION

The Company shall be managed by the managing member.



These Articles of Organization are executed by the organizing member as of 2nd August, 2011.



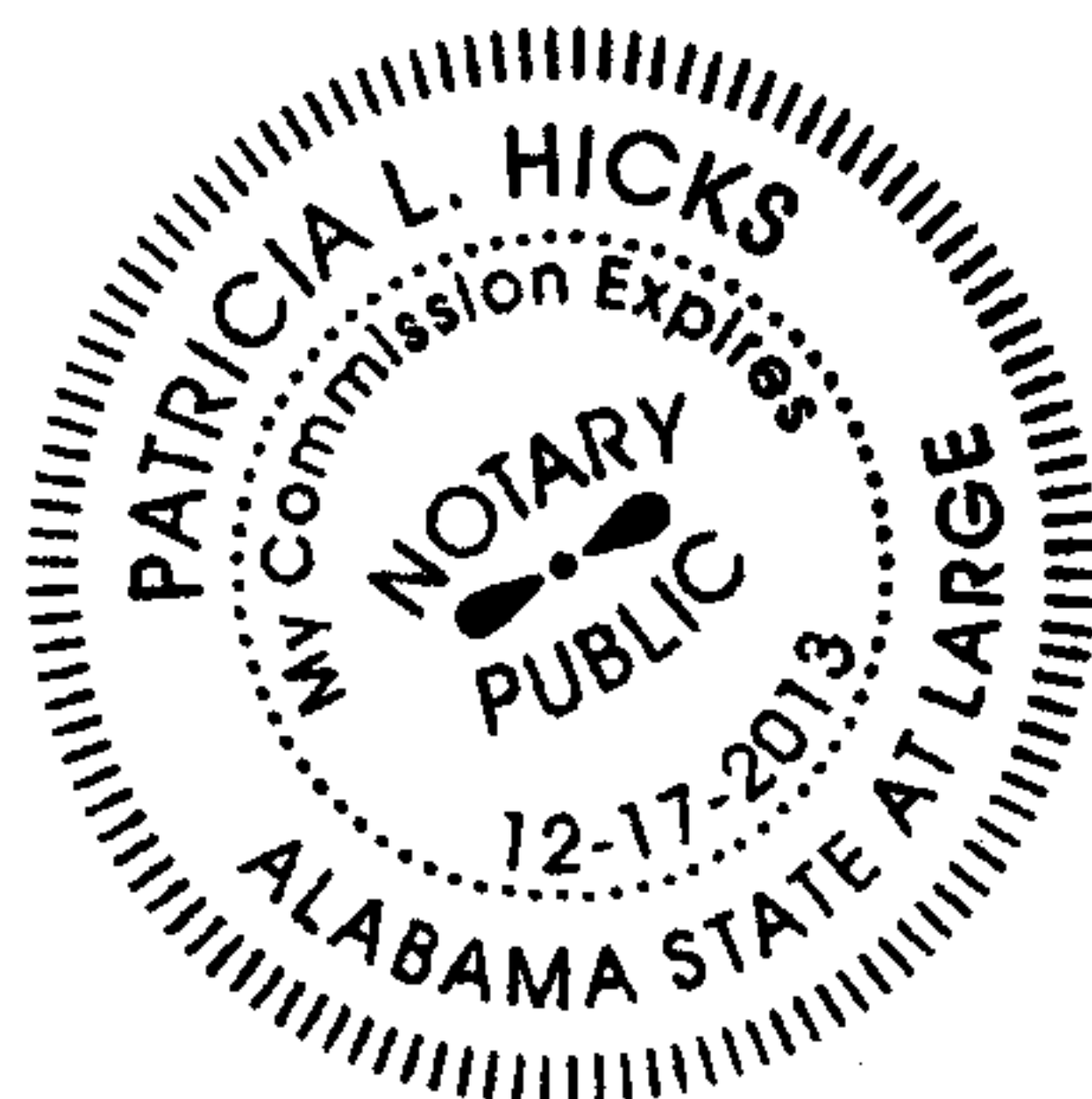


