ARTICLES OF ORGANIZATION

Pursuant to the Alabama Limited Liability Company Act, the undersigned hereby adopts the following Articles of Organization:

**ARTICLE I
NAME AND PRINCIPAL OFFICE ADDRESS**

The name of the limited liability company is I-SEVEN ENTERPRISES, LLC. The principal office address is 413 Saint Anne's Drive, Birmingham, Alabama 35244.

**ARTICLE II
DURATION**

The period of duration of the Company shall be perpetual; provided, that the limited liability company shall cease to exist upon dissolution of the limited liability company in accordance with Section 37 of the Alabama Limited Liability Company Act.

**ARTICLE III
PURPOSE**

The purpose for which the limited liability company is organized is the transaction of any and all lawful business for which a limited liability company may be organized under the Alabama Limited Liability Act, including, without limitation, accommodation and food service; and to do everything necessary, advisable, or convenient, for the accomplishment of the foregoing purposes.

MEMBER-MANAGED**

The Company shall be governed and managed by its Members.

**ARTICLE VII
ADMISSION ADDITIONAL MEMBERS**

Upon written consent of a Majority of the Members, the Company may permit the admission of additional Members and determine the Capital Contributions of such additional Members by the execution of an Admission Agreement. Upon such admission, the existing Members' ownership of Units shall be ratably reduced to provide for the additional Member's ownership of Units.


**ARTICLE VIII
