ARTICLE I: Name

The name of the Limited Liability Company is J.A. Construction LLC (“The Company”)

ARTICLE III: Purpose

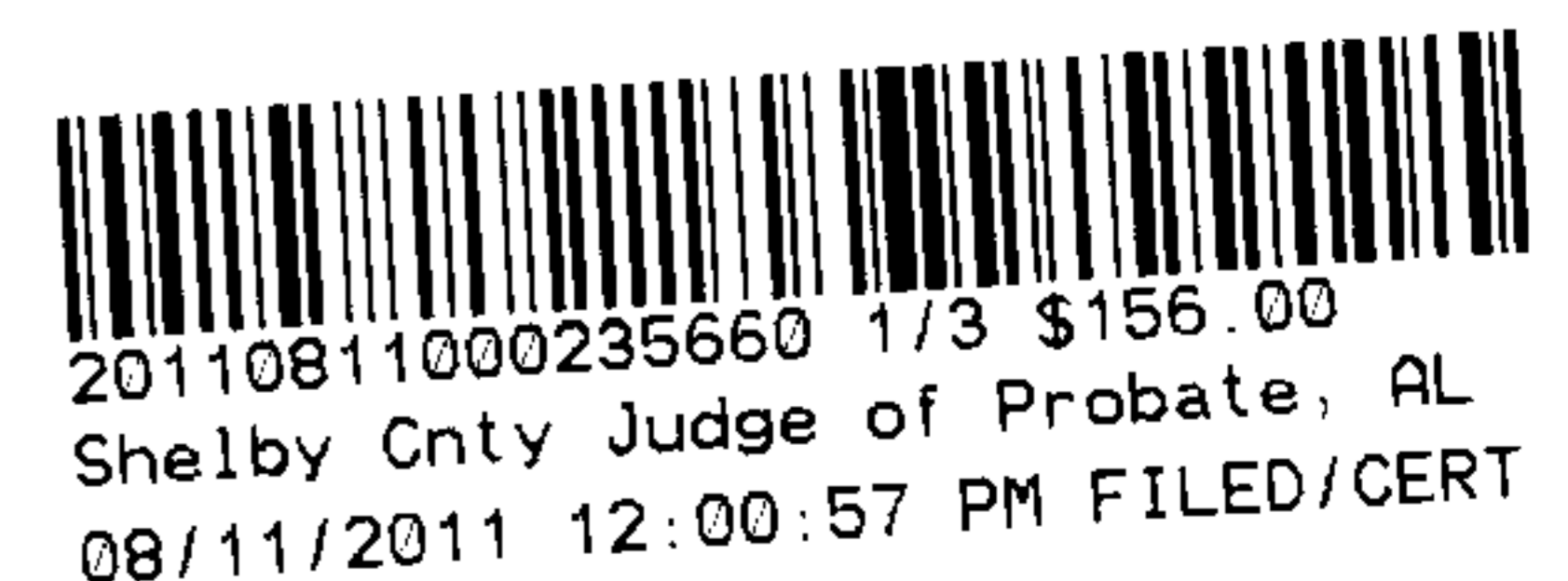
The purposes for which the company is formed are:


ARTICLE VI: Admission of Additional Members:
