

## CERTIFICATE OF INCORPORATION OF

#### SHELBY COUNTY


For the purpose of forming a Corporation under Articles 1 thru 3 of Chapter 2A of Title 10, Code of Alabama (1975), as amended, the undersigned have associated themselves together and have agreed upon and adopted this Certificate of Incorporation, to constitute and become its Charter upon the filing hereof pursuant to law.

#### ITEM I

The name of the Corporation is Alkken, INC.

The purposes and objects for which the corporation is formed are:

- 1. To operate a real estate development and rental business.
- 2. To acquire all or any of the good will, rights, property and business of any person, firm, corporation or association, and to hold, utilize, enjoy and in any manner dispose of the whole or any of the rights, property and business so acquired, and to assume the connection therewith any liabilities of any such person, firm, corporation or association.
- 3. To apply for, obtain, purchase or otherwise acquire any patents, copyrights, licenses, trademarks, tradenames, rights, processes, formulate and the like, which may seem capable of any of the purposes of the corporation and to use, exercise, develop, grant licenses in respect of, sell and otherwise turn to account, the same.




- 4. To borrow money for any of the purposes of the corporation, and to issue bonds, debentures, notes or other obligations of any nature, and in any manner permitted by law, for money so borrowed or in payment for property purchased, or for any lawful consideration, and to secure the payment thereof and of the interest thereon by mortgage upon or pledge or conveyance or assignment in trust of the whole or any part of the property of the corporation, real or persons, including the contract rights, whether at the time owned or thereafter acquired and to sell, pledge, discount, or otherwise dispose of such bonds, notes or other obligations of the corporation for its corporate purposes.
- 5. To guarantee the obligation of any person, corporation or association.
- 6. To have the power to conduct and carry on any business or activity not prohibited by law, nor required by law to be specifically stated in these articles.
- 7. To act as receiver or agent for any person or corporation or in respect to any lawful undertaking or transaction.
- 8. To do each and every thing necessary, suitable or proper for the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated.

#### ITEM II

The name and location of the "Registered Agent" and "Registered Office" of the corporation in the State of Alabama shall be: Kourtney Hayes, 1128 Amberley Woods Dr., Helena, Alabama 35080

The amount of the total authorized capital stock of the Corporation upon its organization, subject to the right of the Corporation hereinafter to increase the same to any amount in the manner provided by law, shall be one thousand shares (1,000) with par value of \$1 per share.
