

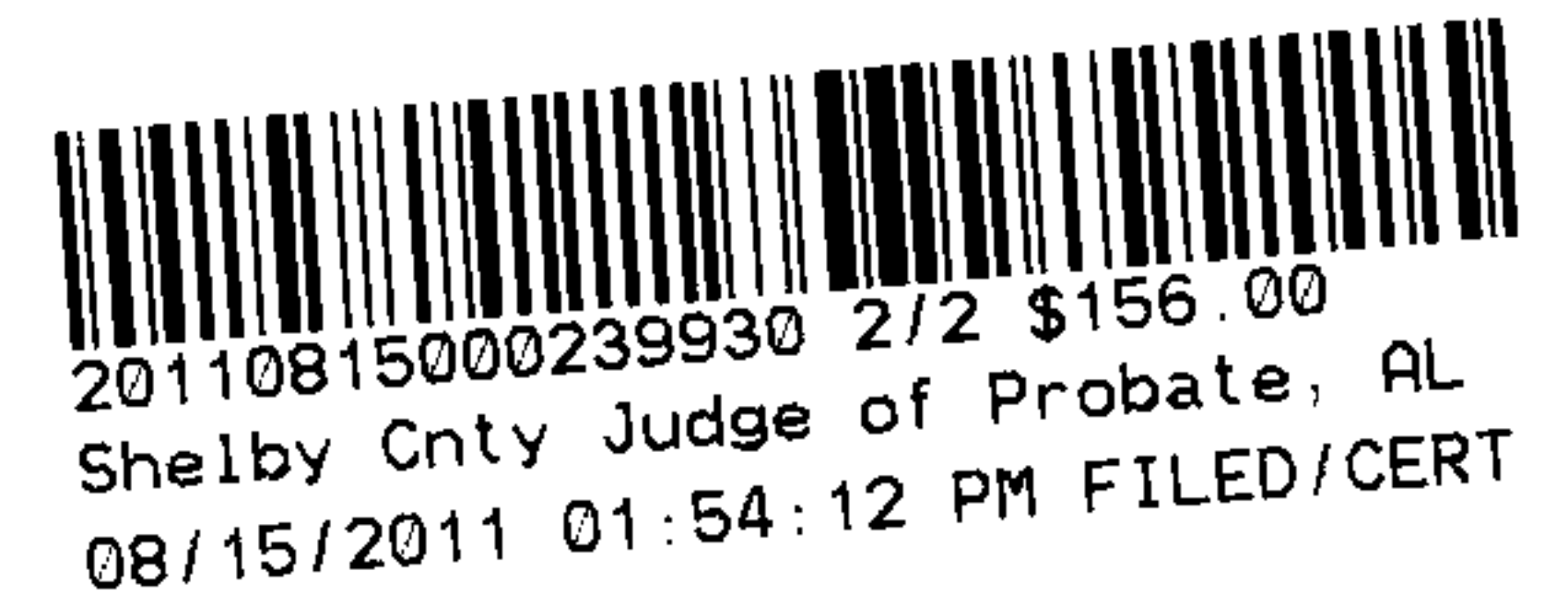

The undersigned does further hereby direct the officers and directors of this company to take such further action as may be necessary or proper to wind up the affairs of this company and to dissolve it.


