

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on, to-wit: the 25th day of June, 2008, ANGELA BRANHAM, single, executed a mortgage to HAMILTON MORTGAGE CORPORATION, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on July 2, 2008, in Instrument 20080702000270070, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to JPMORGAN CHASE BANK, N.A., by assignment dated June 25, 2008, and recorded in Instrument 20080702000270080, Probate Records of Shelby County, Alabama; and


