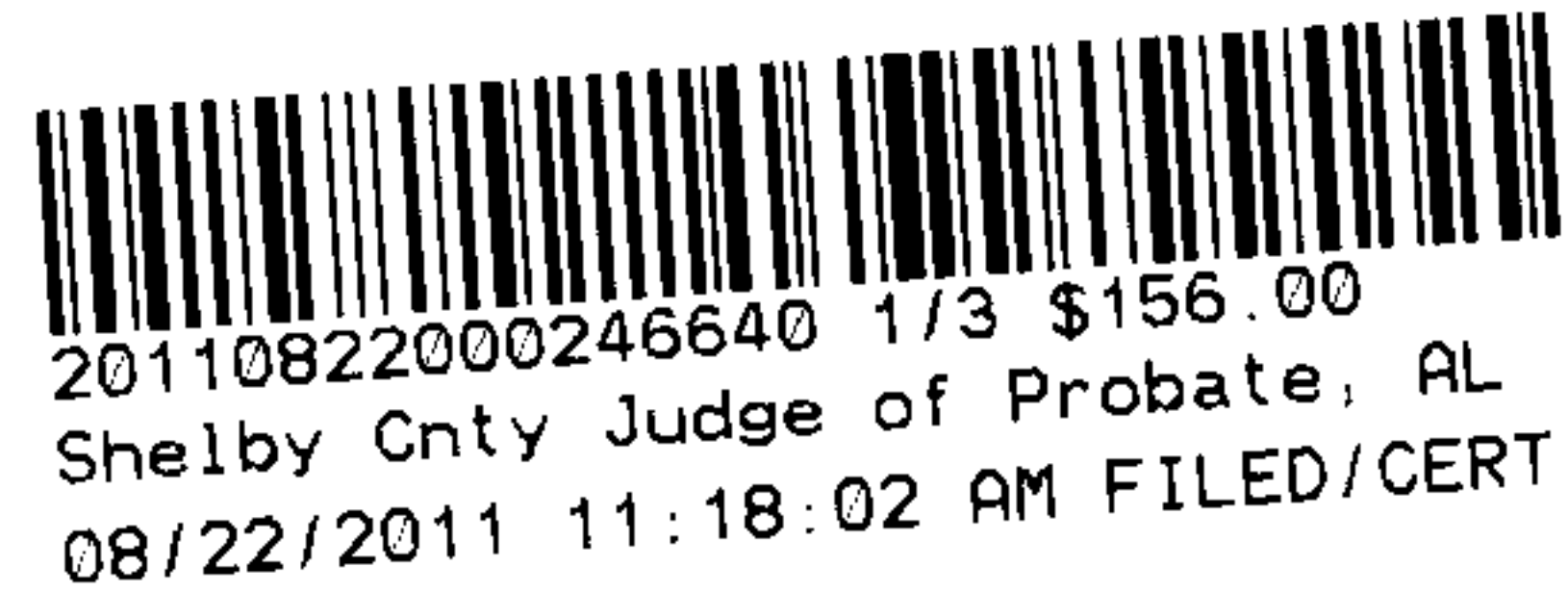


STATE OF ALABAMA
DOMESTIC LIMITED LIABILITY COMPANY
ARTICLES OF ORGANIZATION GUIDELINES



INSTRUCTIONS:

STEP 1: The NAME OF THE LIMITED LIABILITY COMPANY MUST CONTAIN THE WORDS LIMITED LIABILITY COMPANY, LLC OR L.L.C.

STEP 2: FILE THE ORIGINAL AND TWO COPIES OF THE ARTICLES OF ORGANIZATION IN THE COUNTY WHERE THE LLC'S REGISTERED OFFICE IS

LOCATED. THE SECRETARY OF STATE'S FILING FEE IS \$100. PLEASE CONTACT THE JUDGE OF PROBATE TO VERIFY THE PROBATE FILING FEE.

PURSUANT TO THE ALABAMA LIMITED LIABILITY COMPANY ACT, THE UNDERSIGNED HEREBY ADOPTS THE FOLLOWING ARTICLES OF ORGANIZATION.

Articles of Organization
of
The Horse Charmer Tack and Gift Shop LLC

The undersigned, acting as the organizer of a limited liability company under the Alabama Limited Liability Company Act (the Act), hereby adopt the following Articles of organization for The Horse Charmer Tack and Gift Shop LLC (the Company)

ARTICLE ONE

The name of the Company is The Horse Charmer Tack and Gift Shop LLC

ARTICLE TWO

The Company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act.

ARTICLE THREE

The Company is organized for the purpose of conducting the business of:

1. To erect, construct, establish, purchase, lease and otherwise acquire, and to hold, use, equip, outfit, supply, service, maintain, operate, sell, and otherwise dispose of, business and real property, and to engage in all activities, to render all services, and to buy, sell, use and otherwise deal in all fixtures, equipment, accessories, tools, materials, products and merchandise incidental or related here to, or of use therein.
2. To buy, sell, lease, hold, improve and otherwise deal in real and personal property, including securities; to lend and borrow money, with or without interest, with or without security therefore, but nothing contained herein shall be construed to empower this limited liability company to be of a banking, trust or insurance nature.

3. To transact any or all lawful business for which limited liability companies may be organized under the Act

ARTICLE FOUR

The mailing address of the initial registered office is 4 Office Park Circle Ste 110 Birmingham AL 35223, and the name of the initial registered agent of the Company at such address is Robert Cooper CPA

ARTICLE FIVE

ARTICLE SIX

The initial member of the Company may admit additional members at such times and upon such terms and conditions as may be mutually agreed by the Company and the additional members.

ARTICLE SEVEN

The legal existence and business of the Company may be continued by written consent of all the remaining members within 90 days after an event of dissociation of a member.

ARTICLE EIGHT

The Company is to be managed by one or more managers or managing members. The name and mailing address of the initial managing member, who shall serve as manager until the first annual meeting of members of the Company or until successors are duly elected is:
