

WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS, That in consideration of ONE THOUSAND AND NO/100 DOLLARS (\$1,000.00), and any other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, **BERNICE KIDD, an unremarried widow; SHEILA RICH, a married woman; and SANDRA WOOD, a married woman** (herein referred to as grantor) grant, bargain, sell and convey unto **THOMAS O. DIFEE and LEIANN DIFEE** (herein referred to as grantees), the following described real estate, situated in Shelby County, Alabama, to-wit:

All our undivided 1/3rd interest in and to the following described property, to-wit:
A strip of land of a uniform 40-foot width along the Eastern boundary of the SW ¼ of SE ¼, Section 22, Township 20 South, Range 1 East, Shelby County, Alabama. Together with all rights reserved in said strip for a public road, as set forth in deed recorded in Deed Book 264, Page 831, in the Probate Office of Shelby County, Alabama.

Subject to taxes for 2011 and subsequent years, easements, restrictions, rights of way, and permits of record.

The grantors herein constitute all of the heirs at law and next of kin of John C. Kidd, who died on or about the 10th day of May, 2009. Said John C. Kidd was one of three heirs of the Verna Jackson Waddell estate.

TO HAVE AND TO HOLD Unto the said GRANTEES as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said Grantees, their heirs and assigns, and I am (we are) lawfully seized in fee simple of said premises, that they are free from all encumbrances unless otherwise noted above, that I (we) have a good right to sell and convey the same as aforesaid, that I (we) will, and my (our) heirs, executors and administrators shall, warrant and defend the same to the said Grantees, heirs, executors and assigns forever, against the lawful claims of all persons.
