

LESS AND EXCEPT THE FOLLOWING DESCRIBED PROPERTY:

Commence at the NE corner of the NW ¼ of the NE ¼ of Section 8, Township 21 South, Range 4 West and run Westerly along North line of said ¼-¼ section a distance of 330.00 feet; thence turn an angle left of 91 degrees 23 minutes 15 seconds for a distance of 1103.92 feet to point of beginning; thence turn right an angle of 76 degrees 7 minutes for a distance of 207.14 feet; thence turn an angle left of 75 degrees 26 minutes for a distance of 166.10 feet; thence turn an angle left of 87 degrees 56 minutes 30 seconds for a distance of 199.30 feet; thence turn an angle left of 91 degrees 23 minutes 15 seconds for a distance of 220.78 feet to point of beginning.

Commence at the NE corner of the NW ¼ of NE ¼ of Section 8, Township 21 South, Range 4 West and run Westerly along North line of said ¼-¼ section a distance of 330.00 feet; thence turn an angle left of 91 degrees 23 minutes 15 seconds for a distance of 883.14 feet to point of beginning; thence turn right an angle of 91 degrees 23 minutes 15 seconds for a distance of 374.86 feet; thence turn an angle left 91 degrees 23 minutes 15 seconds for a distance of 220.80 feet; thence turn an angle left of 88 degrees 36 minutes 45 seconds for a distance of 374.86 feet;

thence turn an angle left of 91 degrees 23 minutes 15 seconds for a distance of 220.78 feet to point of beginning; being situated in Shelby County, Alabama.

He left surviving him a widow, namely ARTIMACE JORDAN, and three children, namely, JAMES KENT JORDAN, SR., LARRY CHARLES JORDAN and MORRIS WAYNE JORDAN.
