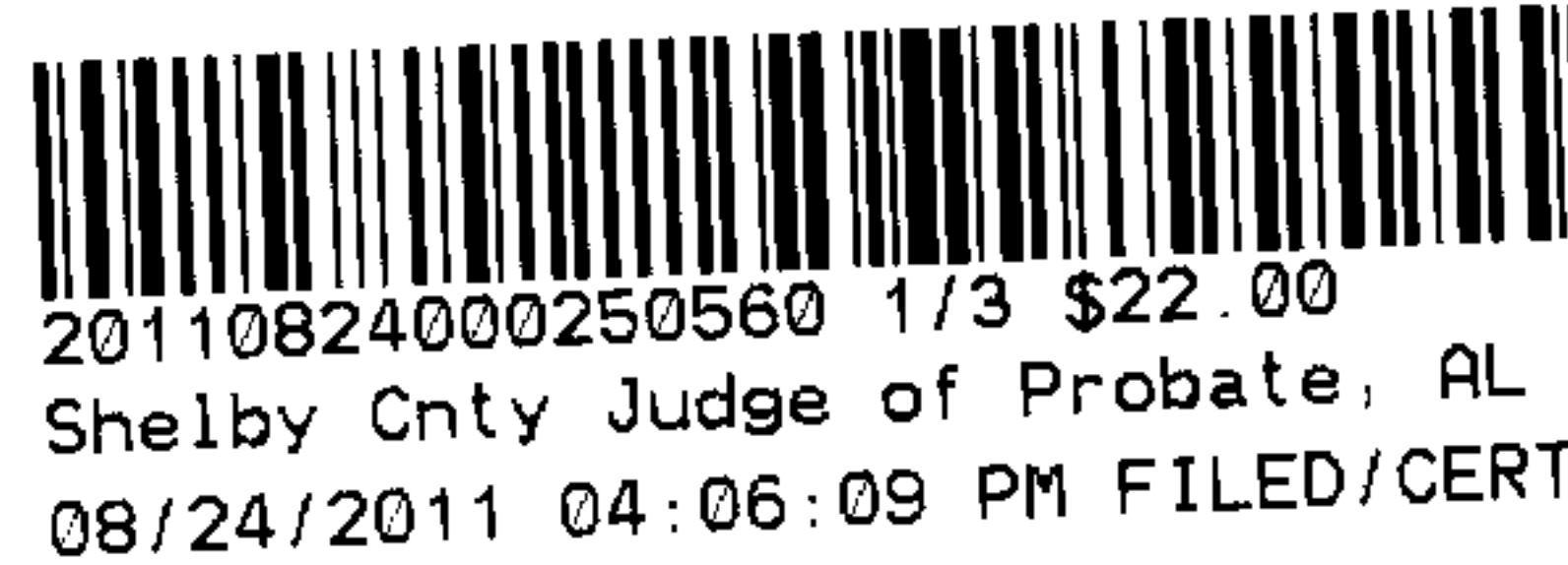

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 28th day of September, 2007, Victor G. Madrid, a married man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Wachovia Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20071003000462350, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A, by instrument recorded in Instrument Number 20110126000028150, in the aforesaid Probate Office ("Transferee"); and

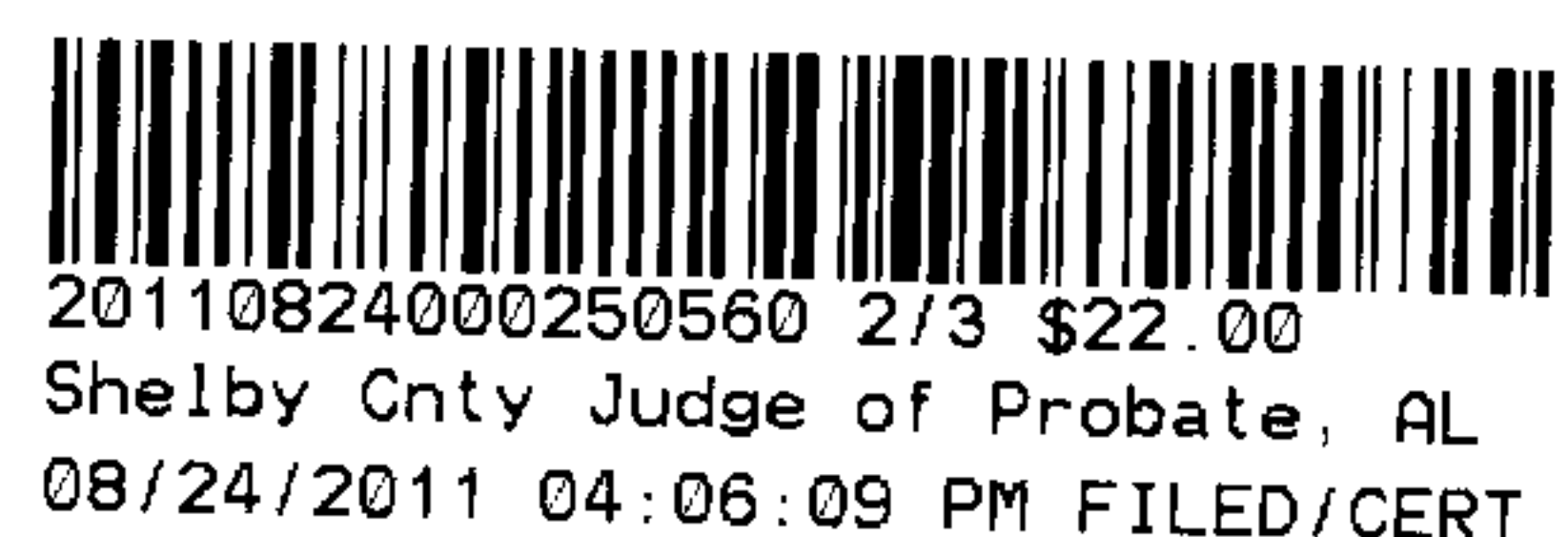


