
PRENUPTIAL AGREEMENT

KNOW ALL MEN BY THESE PRESENCE, this agreement is entered into on the day of Quagust, 2011, between John Dale Parker, hereinafter "Husband" and Janet M. Wise, hereinafter "Wife".

Whereas, the parties contemplate being married under the Laws of the State of Alabama, it is their mutual desire to enter into this agreement so that they will continue to own and control their own property, and are getting married because of their love for each other but do not desire that their present respective financial interests be changed by their marriage, Husband and Wife have agreed as follows:

- 1. The martial residence shall be at 237 Chadwick Lane, Helena, Alabama 35080. Said residence is and shall remain the sole property of Husband until such time as the property is sold, deeded or otherwise legally transferred.
- 2. Husband hereby declares as of the date of this agreement that no one other than himself and Regions bank for an equity line of credit have any claim of legal ownership to the property, in whole or in part, insofar as he is aware.
- 3. Husband shall retain sole ownership interest(s) in his depository accounts, including but not limited to, the checking, savings, money market, Certificates of Deposit, investment and/or retirement accounts.
- 4. Wife shall retain sole ownership interest(s) in her depository accounts, including but not limited to, the checking, savings, money market, Certificates of Deposit, investment and/or retirement accounts.
 - 5. Husband shall bear sole responsibility for his own indebtedness.
 - 6. Wife shall bear sole responsibility for her own indebtedness.



7. Any voluntary financial assistance or voluntary payment by the Husband and/or

Wife on behalf of the other is not construed now or at any time as an assumption of

responsibility for the indebtedness.

8. Any real or personal property acquired by either the Husband or Wife after the

date of this agreement is subject to said agreement.

The property located at 304 Wynlake Drive, Alabaster, Alabama, currently under

mortgage with Everhome Mortgage and equity line with Regions Bank, shall remain the sole

property of Wife until such time as the property is sold, deeded or otherwise legally transferred.

10. Wife shall have sole interest in any proceeds from the lease, rent and/or sale of

Wife's property described above. As of the date of this agreement, said property under a

lease/purchase \$1,000.00 monthly.

11. Until such time as Husband and Wife are legally married, each shall bear the cost

of their individual medical insurance, vehicle insurance and maintenance, pet maintenance,

health care and personal care items, pest control service charges, and home owner's insurance

policies on their respective real estate. At the time Husband and Wife are legally married, they

may agree to consolidate vehicle insurance, to add the spouse to the medical insurance plan

through one of their respective employers, and consolidate other services and bills etc. to lower

the costs and/or increase benefit.

12. At any time hereafter, either Husband or Wife may sell, deed, or otherwise legally

transfer the ownership of any of his or her real or personal property, including that which is

specifically identified in this agreement, one to the other, without altering any portion of said

agreement.
