

Personally appeared before me, the undersigned deponents who being duly sworn, deposes and says on oath the following:

Deponent, Charles S. Lichtman, purchased the property located at 395 Smyer Lake Road, Leeds AL 35094, on September 8, 2008, filed for record on October 3, 2008, in Instrument No. 20081003000393330 and is described as follows:

A tract of land situated in Section 24, Township 18 South, Range 1 West, Shelby County, Alabama, being more particularly described as follows:

82.14 feet; thence turn an angle to the left of 13 degrees 01 minutes 32 seconds and run in a southwesterly direction for a distance of 103.37 feet; thence turn an angle to the left of 07 degrees 12 minutes 17 seconds and run in a southwesterly direction for a distance of 133.71 feet; thence turn an angle to the right of 02 degrees 53 minutes 18 seconds and run in a southwesterly direction for a distance of 129.46 feet; thence turn an angle to the right of 11 degrees 37 minutes 43 seconds and run in a southwesterly direction for a distance of 98.23 feet; thence turn an angle to the left of 12 degrees 47 minutes 49 seconds and run in a southwesterly direction for a distance of 808.85 feet; thence turn an angle to the left of 90 degrees 29 minutes 59 seconds and run in a southeasterly direction for a distance of 548.43 feet; thence turn an angle to the left of 90 degrees 48 minutes 20 seconds and run in a northeasterly direction for a distance of 153.19 feet to the point of beginning.
