ARTICLES OF ORGANIZATION

OF

JAMES BEARDEN AUTOMOTIVE, LIMITED LIABILITY COMPANY

Pursuant to the provisions of Ala. Code, Section 10-12-1, et seq. (this act as amended from time to time is referred to herein as the "Act"), the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE ONE

The Limited Liability Company shall dissolve upon the death, retirement, expulsion, bankruptcy or dissolution of any of the Members of the Limited Liability Company unless there is at least one remaining member and/or the business of the Limited Liability Company is continued within ninety (90) days after the occurrence of the

event of dissociation as permitted by the Act, these Articles, and the Operating Agreement.

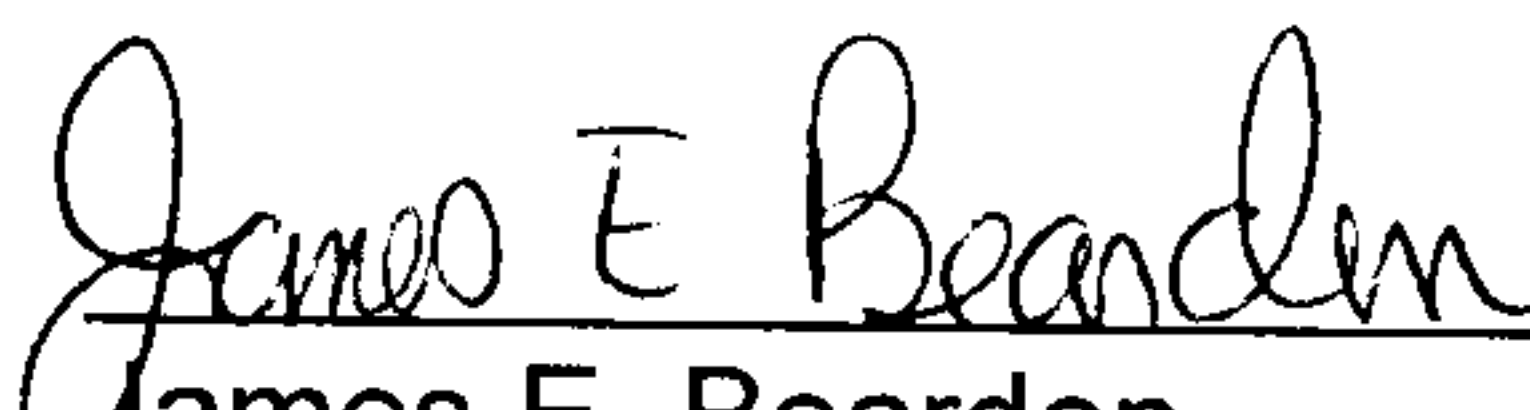

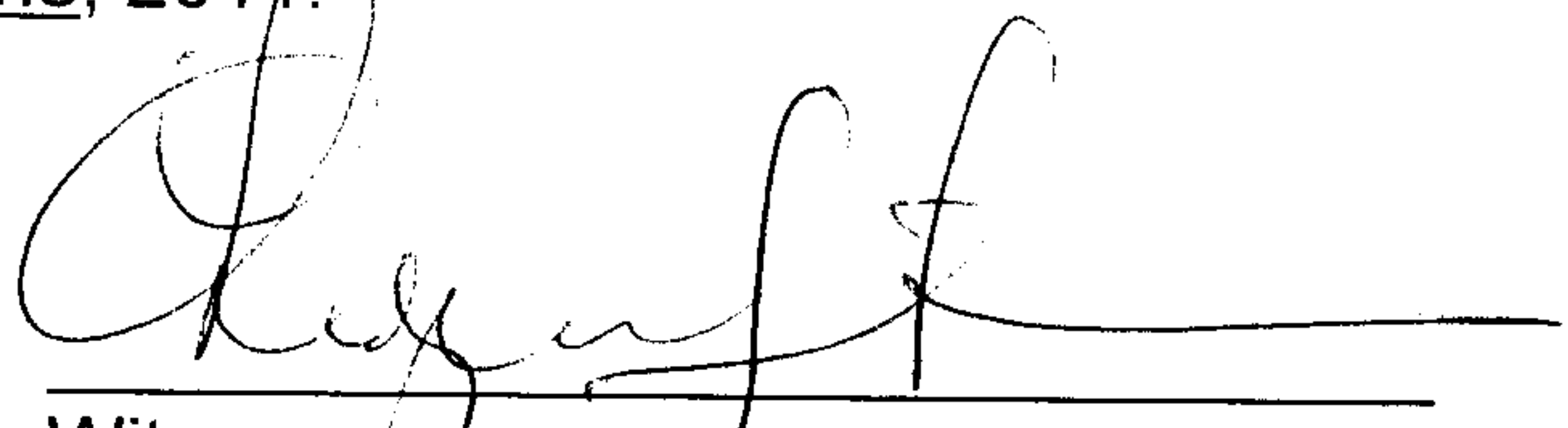
