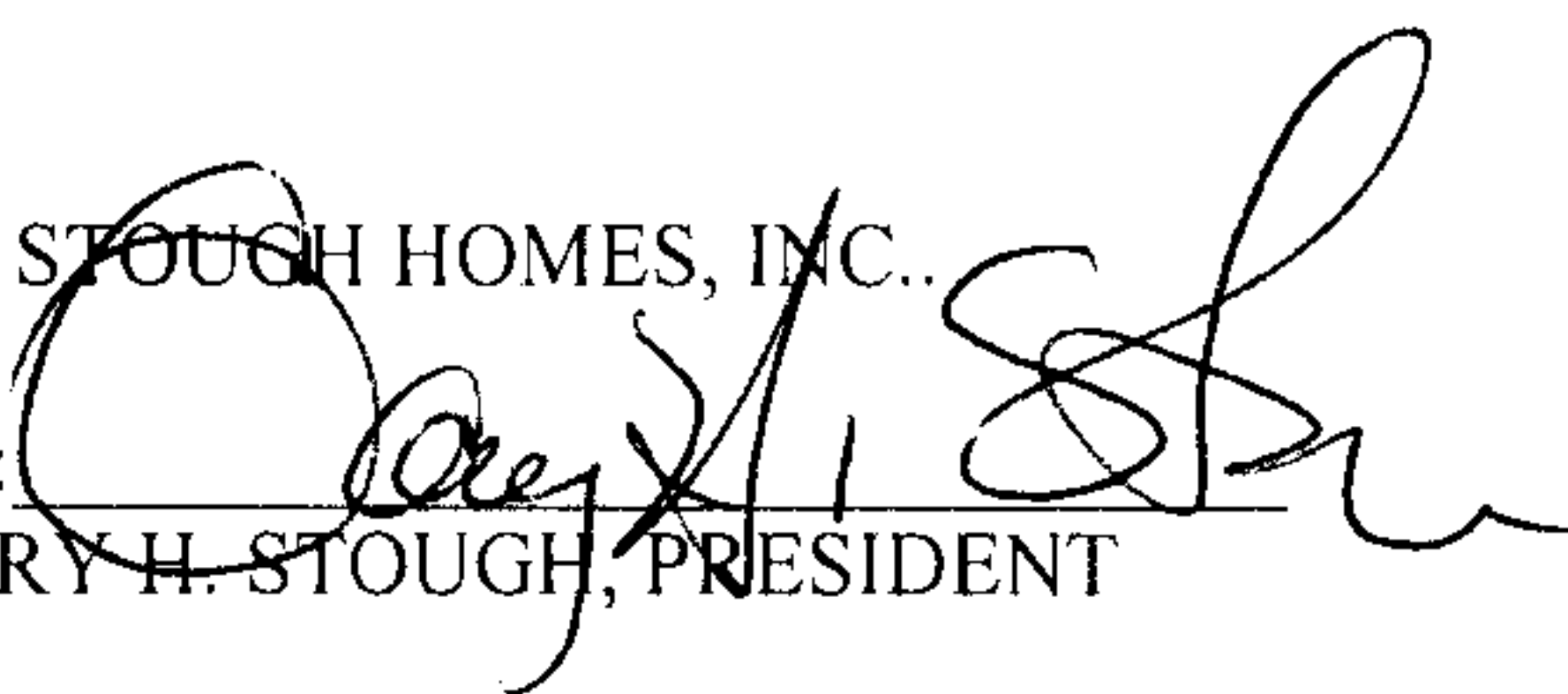
\$260,000.00 of the purchase price received above was paid from a first purchase money mortgage loan closed simultaneously herewith.

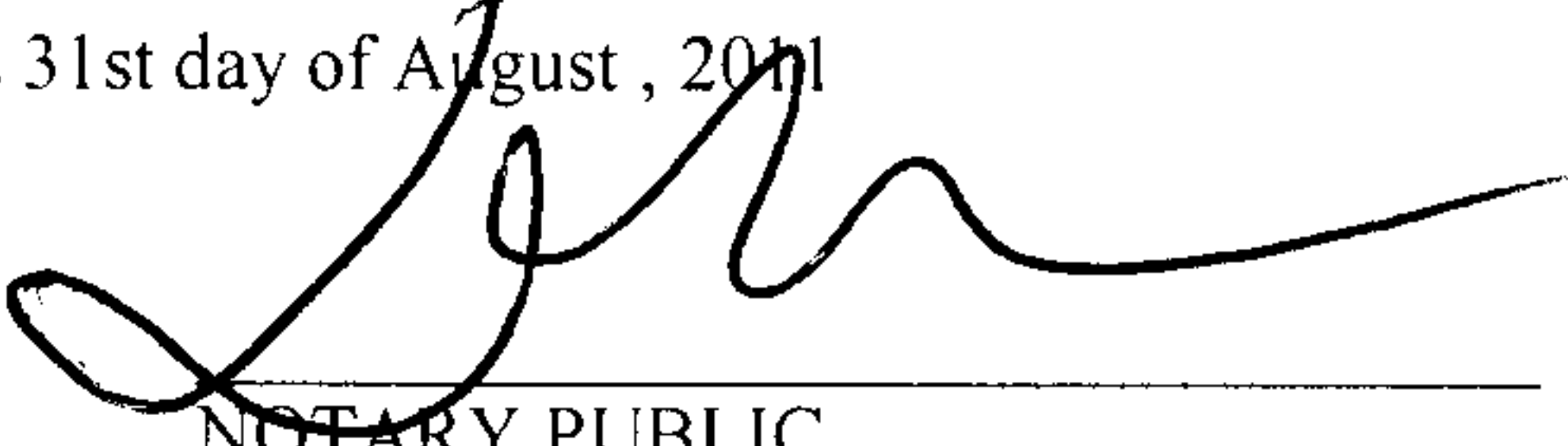
