ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF MONTEVALLO MAIN STREET PLAYERS (An Alabama Non-profit Corporation)

WHEREAS, a special meeting of the Board of Directors was called by Montevallo Main Street Players on the And day of September, 2011 for the purpose of considering the approval of Articles of Amendment to the Articles of Incorporation of said Non-profit Corporation, with there having been a quorum of Directors present; and;

WHEREAS, the President and Chairperson of the Board of Directors of said Corporation, Elaine Hughes, presiding over the meeting of Directors, presented certain matters for consideration to the Directors, and upon motions duly made, seconded and unanimously approved, the Directors voted to adopt certain Articles of Amendment to the Articles of Incorporation of said Corporation; and;

WHEREAS, at said meeting certain resolutions were adopted, as reflected within the minutes of said meeting, all in accordance with the by-laws of the Corporation and the laws of the State of Alabama, pursuant to Alabama Code Section 10A-3-4.01;

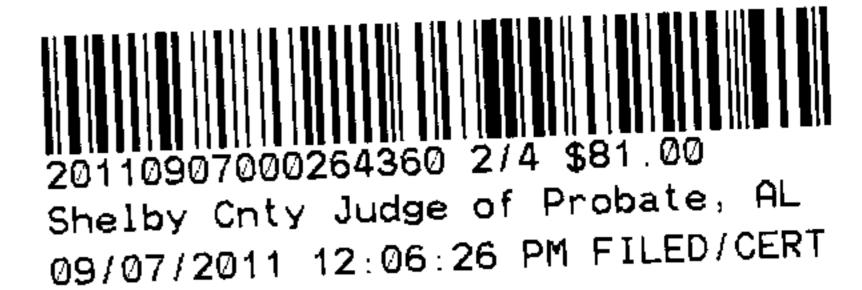
NOW, THEREFORE, be it known to all concerned, that said Corporation hereby adopts the Articles of Amendment to its Articles of Incorporation, more particularly stated as follows:

1. **Article I** of the Articles of Incorporation of said Corporation is hereby amended as follows:

Article I (Name Change)

The name of the Corporation is hereby changed from Montevallo Main Street Players to "MONTEVALLO MAIN STREET PLAYERS, INC.".

2. **Article III** of the Articles of Incorporation is hereby deleted, in its entirety, and the following language is substituted therefor:



Article III (Purpose/Dissolution)

- a. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- b. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Except as herein above amended, all of the remaining Articles of Incorporation of said Corporation shall remain in full force and effect.

These Articles of Amendment to the Articles of Incorporation of said Corporation are executed this 64 day of September, 2011, pursuant to the authority vested in the Board of Directors of said Corporation by the by-laws of said Corporation and the laws of the State of Alabama.

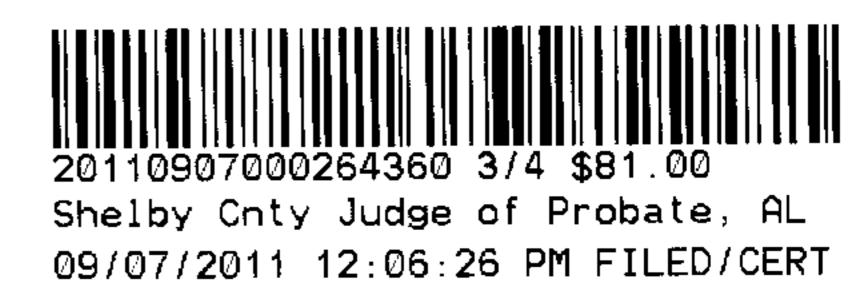
