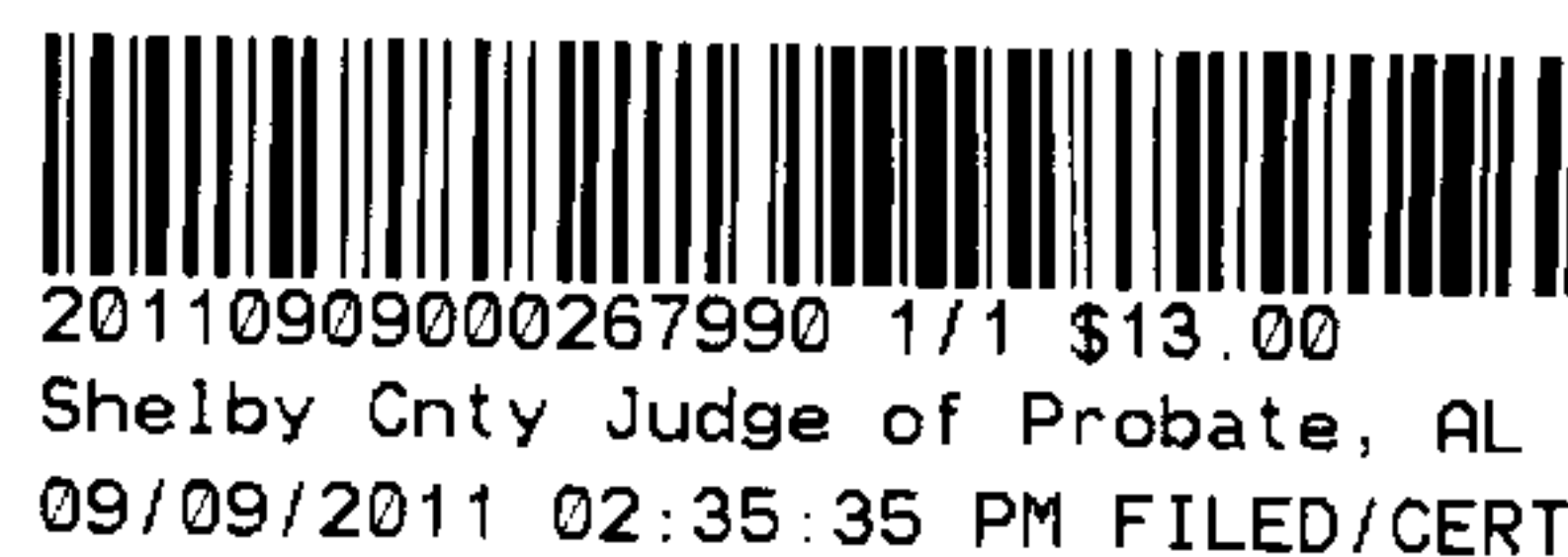

**KNOW ALL MEN BY THESE PRESENTS,** That in consideration of the sum of **One Hundred Forty Nine Thousand dollars and Zero cents ( \$149,000.00 )** paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **Scott Grossman and wife, Shelly Grossman** (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **Battise J. Greene, Sr. and Jamila D. Greene as joint tenants with rights of survivorship** (hereinafter Grantees), all of my/our right, title and interest in the following described real estate, situated in **Shelby County, Alabama:**

Lot 44, according to the Final Plat of Camden Cove, Sector 7, as recorded in Map Book 30, Page 83, in the Probate Office of Shelby County, Alabama.
