

WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of **One Hundred Forty Nine Thousand dollars and Zero cents (\$149,000.00)** paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **Scott Grossman and wife, Shelly Grossman** (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **Battise J. Greene, Sr. and Jamila D. Greene as joint tenants with rights of survivorship** (hereinafter Grantees), all of my/our right, title and interest in the following described real estate, situated in **Shelby County, Alabama**:


Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.


