

## Articles of Organization of EppTech, LLC

The undersigned, being the sole member of **EPPTech, LLC** a limited liability company formed pursuant to Section 10-1-2-1 et. seq. of the Alabama Code, adopts the following Articles of Organization for such company:

**FIRST:** The name of the company is **EPPTech, LLC**.

**SECOND:** The term of the company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall continue for a period of forty (40) years thereafter; provided, however, that the company shall be dissolved prior to such date (a) upon the written consent of the holders of the portion of the ownership interest of the company specified in the Operating Agreement, as amended from time to time, (b) as provided in the Operating Agreement, as amended from time to time, or (c) as may be required by the Alabama Limited Liability Company Act, as amended from time to time.

**THIRD:** The purpose or purposes for which the Company is organized are (i) to provide consulting and other services of every kind and nature; (ii) to buy, sell, own, trade, lease and otherwise handle and deal in, either as principal or agent, and upon commission or otherwise, all kinds of personal and real property whatsoever, and to render services of all kinds and descriptions; and (iii) to transact such other business as may be permitted under the laws of the State of Alabama.

**FOURTH:** The name and address of the initial member of the Company is as follows:

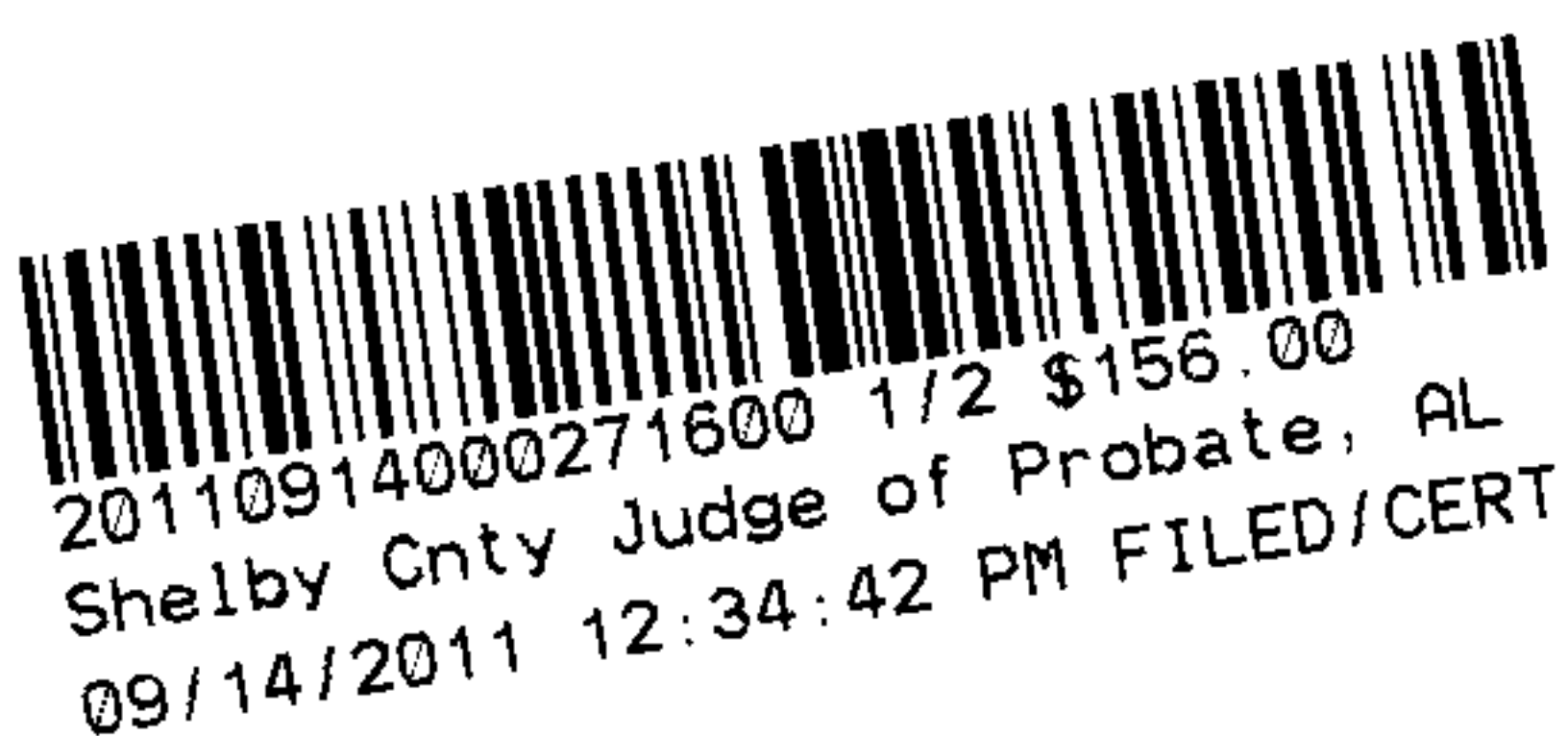

**SEVENTH:** The member or members shall have no right to admit additional members, except in accordance with the Operating Agreement, as amended from time to time.

**EIGHTH:** The cessation of membership of a member will not result in the dissolution of the company, except as specified in the Operating Agreement, as amended from time to time, or as required by applicable law.

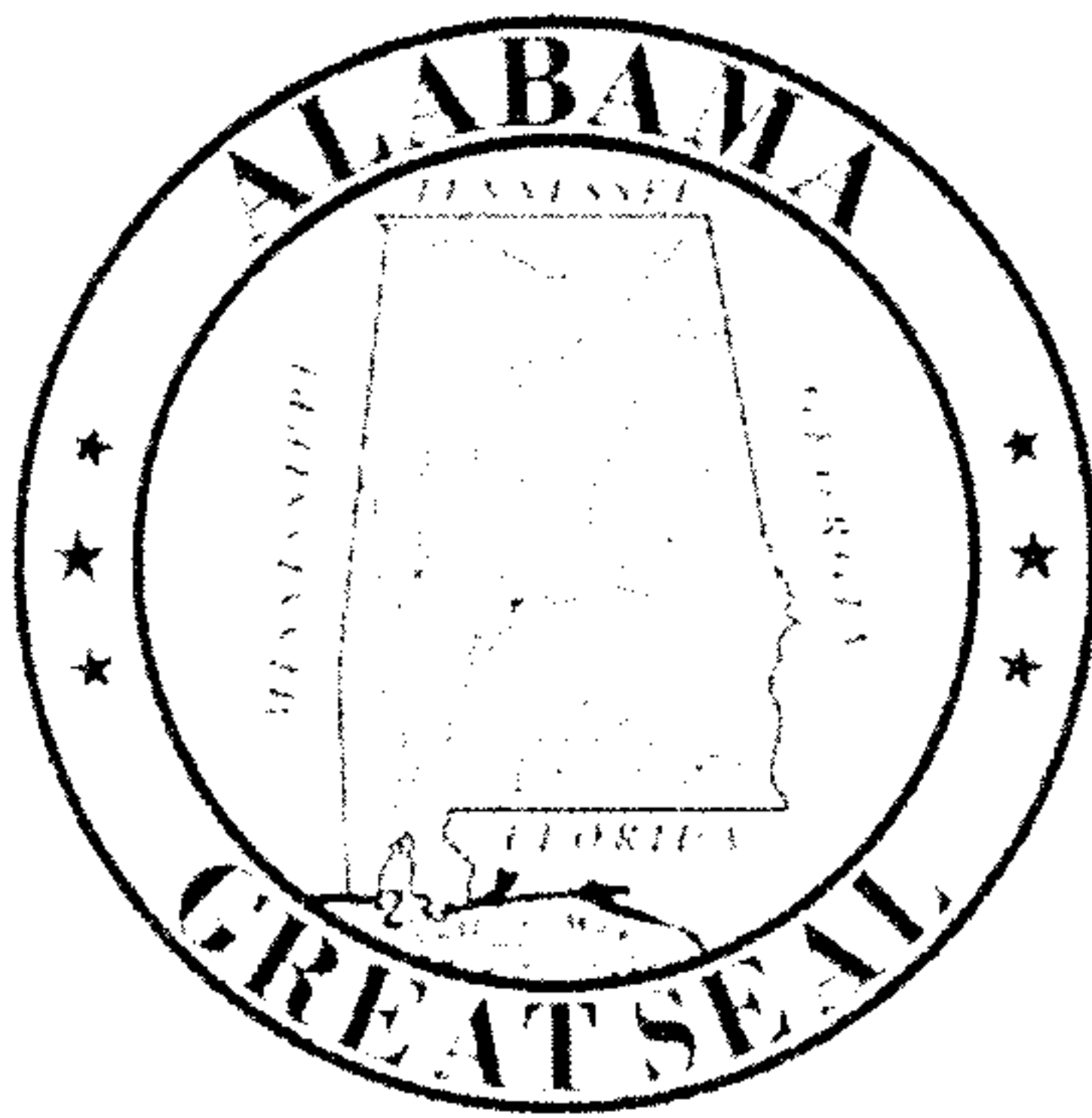
