**ARTICLES OF ORGANIZATION  
OF  
GAMEDAY GIRL STUFF, LLC**

Pursuant to the Provisions of Act No. 93-724, as amended and renumbered by Act No. 2009-513, of the Alabama Legislature, or the Alabama Limited Liability Company Act ("Act"), the undersigned hereby adopt the following Articles of Organization:

**ARTICLE I**

**Name**

The name of the Limited Liability Company is Gameday Girl Stuff, LLC ("Company").

**ARTICLE II**

**Duration**

The duration of the Company shall be perpetual. The Company shall be dissolved and its affairs shall be wound up upon occurrence of the first of the following events:

- a. Written consent of all members to dissolve.
- b. When there is no remaining member, unless the holders of all the financial rights in the Company agree in writing, within 90 days after the cessation of membership of the last member, to continue the legal existence and business of the Company and to appoint one or more new members.
- c. When the Company is not the successor limited liability company in the merger or consolidation with one or more limited liability companies or other entities.
- d. Entry of a decree of judicial dissolution under Section 10A-5-7.02 of the Act.

### **ARTICLE III**

#### **Purpose**

The Company has been organized for the following purposes:

- a. To engage in the design, manufacture, distribution, sale and resale of clothing items and accessories; and
- b. To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act, or the laws of the State of Alabama.

### **ARTICLE IV**

#### **Initial Registered Agent and Office**

The address of the Company's initial registered office in Alabama is 1146 Lake Forrest Circle, Hoover, Alabama 35244. The name of the Company's initial registered agent at that address is Shena McCarty Birdsong.

### **ARTICLE V**

#### **Initial Members**

#### **Management**

The Company is to be managed by its members.

### **ARTICLE VII**

#### **Admission of New Members**

Members of the Company have the right to admit new members on the unanimous written consent of existing members. The existing members shall determine the amount and nature of contributions by new members at the time new members are admitted.

## **ARTICLE VIII**

### **Cessation of a Member**

The remaining members of the Company shall have the right to continue the business after the cessation of a member in the Company upon the unanimous written consent of the remaining members.

## **ARTICLE IX**

### **Powers**

The Company shall possess all of the powers necessary to carry out the purposes expressed herein and all of those powers expressly conferred on limited liability companies by the Act, as well as those necessarily implied.

## **ARTICLE X**

### **Operating Agreement**

The members of the Company may enter into an Operating Agreement to regulate or establish the affairs of the Company, the conduct of its business, and the relations of its members. The Operating Agreement may contain any provisions regarding the affairs of the Company and the conduct of its business that are not inconsistent with the Act or these Articles of Organization.

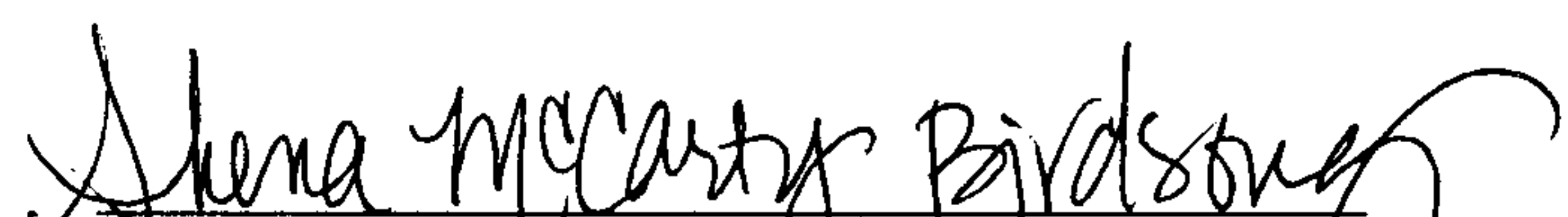
