LIMITED POWER OF ATTORNEY

The undersigned gives to said attorney-in-fact full power and authority to execute such instruments for the limited purpose described above and to carry into effect the power or powers granted by or under this Limited Power of Attorney as fully, to all intents and purposes, as the undersigned might or could do, as if the undersigned were personally present. This Limited Power of Attorney is executed and is effective as of this 18th day of April 2011. This Limited Power of Attorney shall expire and be of no further force or effect on and after April 18, 2012. Notwithstanding anything to the contrary herein, this Limited Power of Attorney may be revoked at anytime.

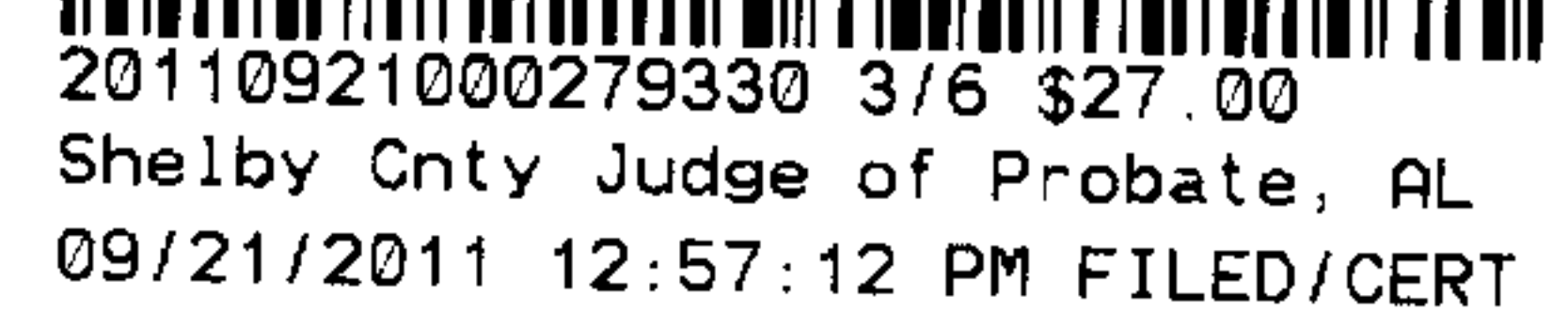

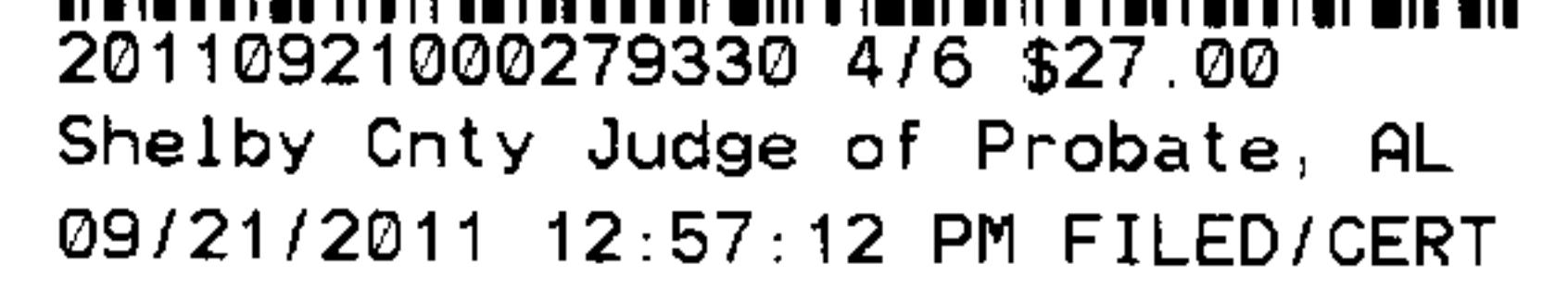
